This budget amendment transfers the salaries and benefits budget that is posted in the ACO Fund to the Facilities Division General Fund, and increases Operating Transfers from the ACO Fund to the General Fund in a commensurate amount.  This budget transfer is part of an accounting update to address an issue with the Countywide Cost Allocation Plan regarding the accounting for salaries and benefits incurred by Facilities staff who work on ACO projects.
