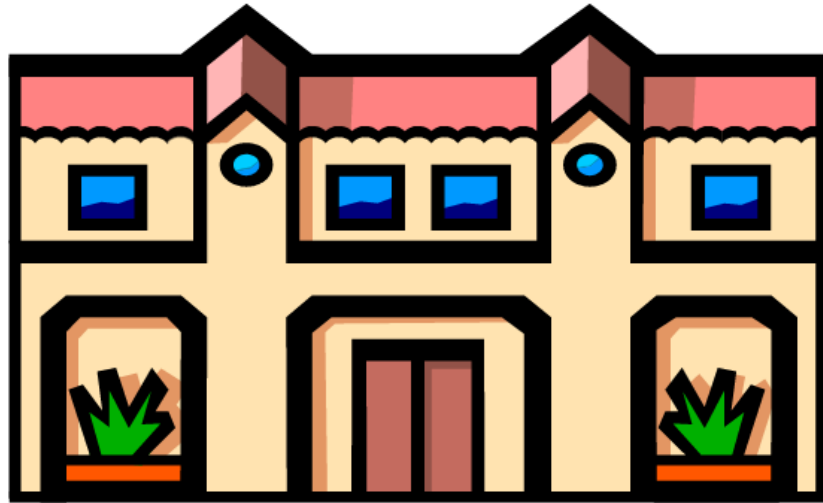

ADA accessible and/or adaptable units for fall prevention. This would include modest sized homes and lots on minimally sloped parcels.

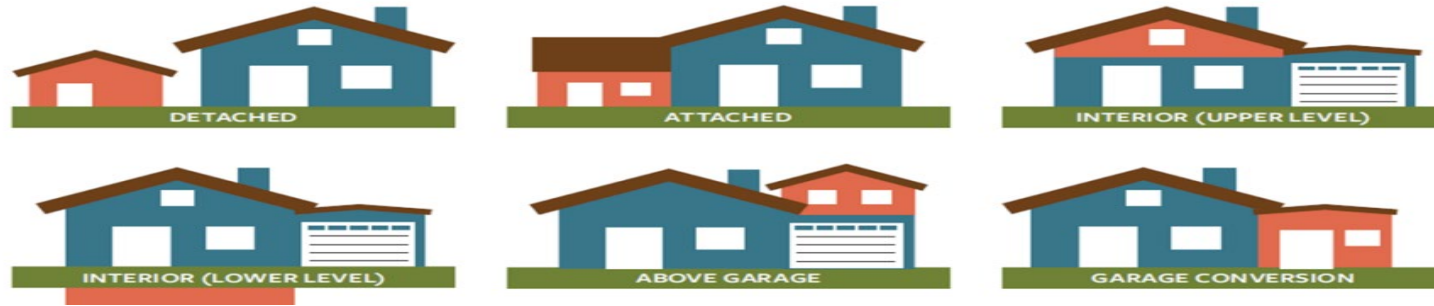
Affordable Housing: Very Low - Moderate income housing for seniors on a fixed income.

Workforce housing: also attractive to seniors who are downsizing.



Senior Housing / Age Restricted: Attractive to seniors who are downsizing and looking for a sense of community.

Accessory Dwelling Units (ADUs), Tiny Homes and Junior Accessory Dwelling Units (JADUs)



El Dorado County reestablished a mobile home park ad hoc committee Oct. 8 to tackle issues regarding mobile home parks.



Multigenerational Housing, i.e. Bridge Meadows

Bridge Meadows uses the power of community to help children heal from the trauma of foster care.

Elders live in the community, serving as mentors, friends, and caregivers to the children and each other, forming a safety net of care and interdependence.





Home Sharing Programs



Share my Home

Shared housing is when two or more people share a living space for mutual benefit. There's usually a “head-tenant,” the owner or renter of a property, and a “sub-tenant,” who moves in after agreeing to terms and conditions, which often includes rent and housework.

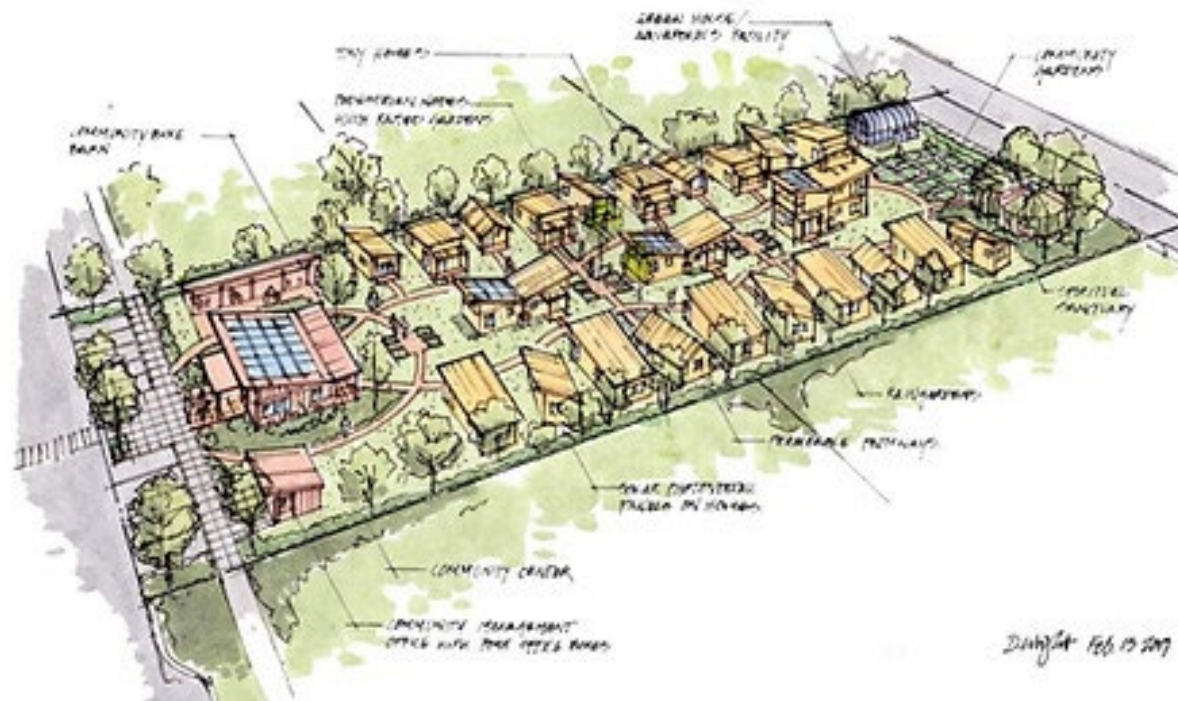

The Village Community Model

The village community model is an innovative approach that combines aging in place with independent living. It promotes aging in place for community-dwelling older adults by creating trusted relationships with neighbors and the wider community.



Missing Middle Housing

Addressing the lack of adequate multi-unit or clustered housing

These housing types fall somewhere in between a single-family home and mid-rise apartment buildings, and include townhomes, duplexes, triplexes, and courtyard clusters.

Missing middle housing is intended to meet the demand for walkable neighborhoods, respond to changing demographics, and provide housing at different price points.
