I have experience working in the County of El Dorado for Senior Legal; Public Guardian; Adult Protective Services as well as El Dorado County Office of Education in past years. I have worked with the State of California for 15 plus years in various divisions too lengthy to mention all. Currently I am assigned to six Deputy Attorneys General wherein we cover law in Health, Education & Welfare; Licensing; Child Support Enforcement; Cannabis Regulation & Employment Administrative Mandate. I have worked with these divisions for 6 plus years and have extensive experience with all related laws and regulations pertaining to same. I am a permanent guardian to a child who has been through the system in one form or another three times and has been under my care most of her entire life through three guardianships, most of which I prepared and oversaw myself after her removal or while her mother was absent in the life of human trafficking. I bring a unique blend of professional and personal lived life experience to any entity I volunteer or work for due to the layers that my family has gone through and how I continue to oversee the needs of my grandchild's mental health needs and what is and is not work in our community of El Dorado County.

Affiliations with professional and/or community groups

I currently serve on the California Department of Justice Disabled Employee's Advisory Committee serving employees throughout the State of California that are disabled, covering unseen and seen disabilities. This month I assisted in putting together the celebration of Disability Awareness Month as well as securing a speaker for the 33rd Anniversary of the Americans with Disabilities Act. Our mission statement includes verbiage pertaining to mental health and unseen disabilities, increasingly apparent after COVID-19 as well as addressing stigma, barriers, and misinformation. We listen, amplify voices and create change. I am a proud member of this committee.

Why do you seek appointment?

Because I took an oath to commit to raising and hopefully adopting my grandchild after her final removal and permanency wherein it is her desire to remain in El Dorado County, in her school, with her friends, teachers, mentors and others we have met along the way though scarce in the Kinship world as opposed to Fosters and Adoptive circles. I seek appointment because my father was a fire fighter in this community who could have used more mental health support, I believe that we need robust services for our law enforcement and fire community, our families, and most importantly our children. I served on many multi-disciplinary teams when working with the Public Guardian and with Adult Protective Services wherein we sought to collaborate together on issues as well as not duplicate work, cases and / or services. I also am part of a system where my grandchild has been connected to services that in the end failed her and I have watched children bounced around agencies as they struggle with things such as employee training, retention, pay and background checks. I would like to be able to also serve my community for the agencies that supported us and support many who got it completely right. It would also be my great joy to sit with Kathryn Hamilton, someone who has inspired me to return to the experience I have to be more involved in my community again after a time of reflection and caring for myself and my family.
