



Amendment No. 1 to Service Agreement

This Amendment No. 1 ("Amendment") is entered into by and between **El Dorado County, a governmental subdivision of the State of California** ("County"), and **Runbeck Election Services, LLC**, an Arizona company ("Runbeck" or "RES"). County and RES may be referred to individually as a "Party" and collectively as the "Parties."

RECITALS:

- A. The Parties entered into that certain Service Agreement dated April 18, 2023 (the "Agreement") for the provision of election equipment, software licenses, and related maintenance and support services.
- B. The Parties now desire to (i) amend the pricing for services, and (ii) update Exhibit D to reflect revised fees, all as set forth herein.

THEREFORE, in consideration of the mutual promises contained in the Agreement and herein, the Parties agree as follows:

1. PRICING AMENDMENT; REPLACEMENT OF EXHIBIT D

Exhibit D is superseded solely with respect to pricing and compensation-related terms, and Exhibit D-1 is incorporated as the controlling schedule for such terms.

3. CONFORMING REVISIONS

To the extent any provision of the Agreement conflicts with this Amendment, this Amendment shall control. All other terms, conditions, exhibits, and provisions of the Agreement remain unchanged and in full force and effect.

4. NO OTHER MODIFICATIONS

Except as expressly set forth herein, this Amendment does not modify, alter, or amend the Agreement in any other respect.

5. COUNTERPARTS / ELECTRONIC SIGNATURES

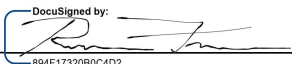
