Re: Resolution Consolidating El Dorado Irrigation District Board Elections

Dear Mr. Mitrison:

Enclosed please find a certified copy of Resolution No. 2015-007 of the El Dorado Irrigation District Board of Directors, to consolidate the District's elections (currently held in odd-numbered years) with the statewide general elections held in even-numbered years. This resolution is authorized by and was adopted pursuant to Elections Code Section 10404. Before it can become effective, however, it must be approved by the Board of Supervisors in each county in which the District is located.

Pursuant to subdivision (c) of Section 10404, the Board of Supervisors is to notify all districts located in the County of its receipt of this resolution, and request their input on the effect of consolidation. Please ensure that this notification is made.

Pursuant to subdivision (e) of Section 10404, the Board of Supervisors is to approve the District's resolution within 60 days of submission, unless the Board of Supervisors finds that the ballot style, voting equipment, or computer capacity is such that additional elections or materials cannot be handled. Please agendaize this matter for the Board of Supervisors within the statutory time frame, and advise the undersigned of the date and time it will be heard. The Board is also to obtain a report from the County Elections Official on the cost-effectiveness of the proposed action. By copy of this letter and enclosure to William E. Schultz, the District respectfully requests that he provide the required report to the Board of Supervisors.
