ORDINANCE NO. 5244

AN ORDINANCE TO REPEAL
TITLE 2, CHAPTER 2.20,
ARTICLE X, SECTIONS 2.20.660
THROUGH 2.20.750 PERTAINING
TO THE PARKS AND RECREATION
COMMISSION

Whereas on September 23, 2025 the Board of Supervisors (Board) provided conceptual approval to repeal County Ordinance Code Title 2, Chapter 2.20, Article X, entitled Parks and Recreation Commission, Sections 2.20.660 through 2.20.750, ordinances 3848 and 5051 referenced collectively as Exhibit A, pertaining to the Parks and Recreation Commission as an advisory board to the Board of Supervisors; and

Whereas the Board approved the Introduction of this ordinance on October 28, 2025 and simultaneously adopted Resolution 151-2025 to establish Parks and Recreation Commission;

THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:

Section 1.

Ordinances 3848 and 5051 which added Article X (Sections 2.20.660 through 2.20.750) to Chapter 2.20 of the El Dorado County Ordinance Code entitled "Parks and Recreation Commission" are repealed in their entirety and shall be of no further force and effect.
