EL DORADO COUNTY, CALIFORNIA DEFERRED COMPENSATION PLAN ADMINISTRATION AGREEMENT AMENDMENT I

The El Dorado County Deferred Compensation Plan Administration Agreement (the "Agreement") entered into by and between the County of El Dorado, California, a political subdivision of the State of California (hereinafter referred to as the "Employer"), and Nationwide Retirement Solutions, Inc., an indirect subsidiary of Nationwide Financial Services, Inc. (hereinafter referred to as "NRS"), with an effective date of April 10, 2007, is hereby amended, effective this day of 3009, as set forth below. NRS is a Delaware corporation with its principal place of business at 5900 Parkwood Drive, Dublin, Ohio, 43016, and it is duly qualified to conduct business in the State of California.

WHEREAS, NRS is one of the administrators of the El Dorado County, California Deferred Compensation Plan (the "Plan");

WHEREAS, Washington Mutual Bank, FA ("WAMU") currently provides certificates of deposit and liquid savings accounts (the "WAMU Products") as investment options under the Plan;

WHEREAS, WAMU no longer wishes to provide the WAMU Products as investment options under the Plan;

WHEREAS, Nationwide Bank ("NW Bank") offers certificates of deposit and liquid savings accounts similar in form to the WAMU products (the "NW Bank Products"), and has offered to provide the NW Bank Products as investment options under the Plan; and

WHEREAS, the Employer has instructed NRS to replace the WAMU Products with the NW Bank Products and accordingly transition all funds from the WAMU Products to the NW Bank Products;

NOW, THEREFORE, the Employer and NRS hereby agree that the Agreement is to be amended to reflect the above as follows:

I.

Effective (22), 2009, subsections A. and B. of Section 3. of the Agreement are hereby deleted, and the remaining subsections of Section 3. of the Agreement shall be renumbered accordingly.

II.

Effective 22, 2009, Exhibit A to the Agreement is hereby deleted and replaced with the attached, updated Exhibit B to the Agreement.

Except as set forth herein, all other terms and conditions of the Agreement shall remain in full force and effect; provided, however, in the event of any conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall control. No amendment or

modification of this Amendment shall be effective unless signed by authorized representatives of both the Employer and NRS.
