**NOTICE OF PUBLIC HEARING**  
**NOTICE IS HEREBY GIVEN** that at 9:00 a.m. or as soon thereafter as the matter can be heard, on Tuesday, October 14, 2014, at the El Dorado County Board of Supervisors Meeting Room, Building A, 330 Fair Lane, Placerville, California 95667, the governing body of the County of El Dorado (the "County"), will conduct a public hearing concerning a plan of finance for the issuance by the California Statewide Communities Development Authority (the "Issuer") of one or more series of its tax-exempt obligations in an aggregate principal amount not expected to exceed \$50,000,000 (the "Obligations"). Proceeds of the Obligations are to be made available to California Shock Trauma Air Rescue, a California nonprofit public benefit corporation (the "Borrower"), pursuant to one or more Loan Agreements (the "Agreements") to provide for the financing or refinancing of air rescue helicopters and related equipment and property (the "Equipment") and to pay related expenses. The Equipment will be located at one or more of the following addresses: (i) 13750 Lincoln Way, Auburn, CA 95603; (ii) 177 John Glenn Drive, Concord, CA 94530; (iii) 540 Cohansey Ave., Gilroy, CA 95020; (iv) 1351 S. State St., Ukiah, CA 95482; (v) 20A Mortensen Ave., Salinas, CA 93905; (vi) 1901 Airport Blvd., South Lake Tahoe, CA 96150; (vii) 3996 Mitchell Road, Santa Maria, California 93455, (viii) 301 Country Airport Road, Vacaville, CA 95688; (ix) 4933 Bailey Loop, McClellan, CA 95652; (x) 4917 Bailey Loop, McClellan, CA 95652; and (xi) near 8991 Earhart Road, Oakland, CA 94621 at North Field, Oakland International Airport, L310-A, and will be owned and operated by the Borrower.

The Obligations will be paid entirely from repayments by the Borrower under the Agreements. Neither the faith and credit nor any taxing power of the County, the Issuer, the State of California (the "State") or any other political corporation, subdivision or agency of the State is pledged to the payment of the principal of or premium, if any, or interest with respect to the Obligations, nor shall the County, the State or any other political corporation, subdivision or agency of the State be liable or obligated to pay the principal of or premium, if any, or interest on the Obligations.

The public hearing is intended to comply with the public approval requirements of Section 147(f) of the Internal Revenue Code of 1986, as amended.

Those wishing to comment on the Agreements, the Obligations or the nature and location of the Equipment may either appear in person at the time and place indicated above or submit written comments, which must be received prior to the public hearing, to County of El Dorado at 330 Fair Lane, Placerville, California 95667, Attention: Clerk of the Board of Supervisors.
