

I want to thank the board of supervisors for listening to my objection of this emergency moratorium.

I'm violating my HIPPA rights to privacy by telling you this, but this is important! I want you to know I am a Medical Cannabis patient. I was in a tragic car accident in 2000 that wiped out my lower spine. It was so badly damaged there was no bone left to repair. I now have part of another human's spine, two rods, 4 screws and a neuro stim implant for pain. I no longer can go through normal security measures (x-ray machines) because if not calibrated properly, it will fry my spinal cord and leave me paralyzed. The pharmaceuticals they put me on for this injury put me in a coma for 7 days and almost killed me. I have nerve damage and the pain is torture. Sativex is made by GW Pharmaceuticals and distributed in 28 countries. It is a legally approved cannabis extract used for MS and spasticity and has shown no addictive qualities, no withdrawal and there have been no fatalities.

Per Kaiser Representative Katie Minke in Sacramento "Kaiser does allow Doctors to recommend medical cannabis if felt to be clinically appropriate and beneficial."

University of Davis's Barth Wilsey M.D. trained in anesthesiology and neurology pain (nerve damage) management has proven the neuro pain killing effect in patients suffering from AIDS, Cancer and Glaucoma.

For instance any changes with the respect to drugs or illegal immigration could affect the number of persons arrested, convicted and sentenced. Thereby reducing demand for our Correctional facilities to house them."

This leads to judges taking kickbacks from the builders of prisons to be hard on defendants. This is already happening as in the conviction of ex-judge Mark Ciavarella. He will be spending at least 13 years in prisons and caused several hundred cases to be immediately thrown out of court.

The U.S. Prison system is run for profit and worth 59.5 BILLION dollars a year. The prisons are floated on the stock market and shares are bought and sold based on how many prisoners are in jail. Do you see a pattern here?

I want to remind you that the dollars spent in prosecuting us will be wasted. There is a Constitutional Doctrine called Jury Nullification that allows juries to acquit defendants who are technically guilty but who don't deserve punishment. When a jury disregards the evidence and acquits an otherwise guilty defendant it has practiced Jury Nullification. This is the jury saying that the law is unfair, either generally or in this particular case.

A recent Gallop pole showed 50% of Americans in favor of legalization with 46% opposed and 4% undecided. We are the majority. Other polls are showing as high as 70% or more in favor of legalization.

Our Federal Govt. would love for you to be a follower and believe their horror stories. We all know they have lied about Cannabis and Hemp.

It is time our representatives represented us. We have been persecuted too long for a plant God put on earth to help mankind.

I want to leave you with a final thought; This is the fork in the road. The Federal Govt. has made 72 million dollars more available to California since Oct 7, 2011. Are you going to take the federal dollars and enforce federal law in lieu of upholding the will of the people of California?
