Vickie et al,

This unlawful one-way monolog has got to end!! **(Shelley and/or Don Ashton please ensure this correspondence is forwarded immediately to Vickie Sanders.)**

Chelsea's unfamiliarity with standard policies, practices & protocols is no excuse. The public has a right to know in advance in order to participate in the meeting.

Should you unlawfully proceed with the PRC meeting, then ensure the entirety of this correspondence is posted for the record in Agenda Item #3 – Whitewater Park on the SFAR.

The Brown Act is being perpetually violated. During our both conversations I specifically pointed out numerous Brown Act violations during the 2/11/19 RMAC, specifically agenda item #4 – *Member Anderson requesting the Committee discuss the development of a whitewater play park on the S. Fork American River*. This was a discussion item, but RMAC illegitimately took action resulting in it being put on today's P/R Commission agenda item #3. Furthermore it was falsely represented in the minutes and your staff failed to make corrections. **We discussed this at length, so don't play games with me.**

Please note:

"The Act punishes attendance by a member of a body (RMAC & PRC) at a meeting where action is taken in violation of the Act, and where the member intends to deprive the public of information to which the member knows or has reason to know the public is entitled. (§ 54959) The term "action taken" as defined by section 59252.6 includes a collective decision, commitment or promise by a majority of the members of a body. The fact that the decision is tentative rather

*than final **does not shield participants from criminal liability**...demonstrating that a pattern of past conduct indicates the existence of present or future violations (Shapiro v. San Diego City Council 2002 96 Cal. App. 4th 904; Duval . Board of Trustees (2001) 93 Cal. App. 4th 902, 906)...The court indicated that since the city would not admit to a violation it was likely that the current practices would continue. The court in Common Cause v. Stirling (1983) 147 Cal. App. 3d 518,524, concluded that the courts may presume that a municipality will continue similar practices in light of the of the city attorney's (COUNTY COUNSEL) refusal to admit the violation."*
