## PowerPoint Display – Slide #2 – Goals for Presentation:

Goal 1: How do we define reentry and current resources for programming and connections to resources in the community?

- EDCOE, Carey B: It always reminds me of, you know, transition is the word and education we talk about transition services being a service that gets provided to students or inmates, in this case from the day they enter the facility, your transition starts and what that means is you're doing whatever assessment you're identifying what their needs are. And while they're with you, making those necessary connections, whether it's internally or externally with other programming. To really identify what the needs are and making sure that you can make that that warm hand off.
- PROBATION, Romanko: Brief overview of the Sheriff's Lt. Bloxsom efforts around "Doc Ready" and his approach to reentry efforts with housing. And if we could explore something like that again, that would be helpful in my opinion. And with the goal to establish protocol between agencies to make sure everybody's on the same page with.
- BEHAVIORAL HEALTH: Nicole EB: It's important for the behavior health needs of the population for us to try as best as possible to seamlessly make that referral and that hand off into services. Once individuals are being released back into the community and I know it's a difficult process, it's a challenge. Enhanced Care is coming soon for the entire population, and we can link into that process of making sure that when we know somebody is going to be released that that connection happens. But these kind of protocols and procedures, we really must work out to make sure that that's a seamless as possible.
- SHERIFF: Implementing anything new for us is going to be very challenging. As of now our biggest problem right now is staffing and space for any additional programs. We have to be selective on what we move forward with and make sure we are selecting the most important things to move forward with.
