

AGREEMENT FOR SERVICES #627-S1310
AMENDMENT III

This Third Amendment to that Agreement for Services #627-S1310, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Phil Dannaker, a private investigator, dba Mother Lode Investigations, duly qualified to conduct business in the State of California, whose principal place of business is 5581 Manzanita Lane, Placerville, CA 95667; (hereinafter referred to as "Contractor");

RECITALS

WHEREAS, Contractor has been engaged by County to provide investigation services on an “as needed” basis for the Public Defender’s Office, in accordance with Agreement for Services #627-S1310, dated July 12, 2013; Amendment I, dated January 1, 2014, and Amendment II dated June 27, 2014, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement for an additional three (3) months, hereby amending **ARTICLE II – Term**; and

WHEREAS, the parties hereto have mutually agreed to increase the compensation for services for the extended term by Twenty-Seven Thousand dollars (\$27,000) hereby amending **ARTICLE III – Compensation for Services**; and

NOW THEREFORE, the parties do hereby agree that Agreement for Services #627-S1310 shall be amended a third time as follows:

ARTICLE II

Term: The term of this Agreement, as amended, shall cover the period of July 1, 2013 through December 31, 2014.

ARTICLE III

Compensation for Services: For services provided herein, County agrees to pay Contractor monthly in arrears and within thirty (30) days following the County’s receipt and approval of itemized invoice(s) identifying services rendered. For the period of October 1, 2014 through December 31, 2014, the billing rate shall be Forty-Seven Dollars and Fifty cents (\$47.50) per hour. The total payment pursuant to this Agreement shall be amended to increase the total by Twenty-Seven Thousand dollars (\$27,000). Total payment amount of this Agreement, as amended, shall not exceed One Hundred Sixty Thousand Eight Hundred dollars (\$160,800) including expenses.

Except as herein amended, all other parts and sections of that Agreement #627-S1310 dated the 12th day of July, 2013; the First Amendment made and entered into the 1st day of January, 2014 and the Second Amendment made and entered into the 27th day of June, 2014 shall remain unchanged and in full force and effect.
