The County of El Dorado Planning Commission will hold a public hearing in the Building & Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on February 13, 2014, at 8:30 a.m., to consider the following: Tentative Map Revision TM07-1458-R/Boundary Line Adjustment BLA13-0015/Miguelina submitted by SHAN NEJATIAN and MARIE MITCHELL to request a Boundary Line Adjustment and revision to an approved Tentative Subdivision Map with phasing plan to create eight single-family residential lots ranging in size from 3 to 4.5 acres. The property, identified by Assessor's Parcel Number 110-020-45, consisting of 26 acres, is located on the west side of Kalla Way, approximately 580 feet north of the intersection with Salmon Falls Road, in the El Dorado Hills area, Supervisorial District 1.
