

**CANCELLATION ADDENDUM TO THE CONSTRUCTION RESPONSIBILITY AND  
REIMBURSEMENT AGREEMENT  
BETWEEN THE COUNTY OF EL DORADO AND THE EL DORADO IRRIGATION DISTRICT  
FOR THE DUROCK ROAD AND BUSINESS DRIVE TRAFFIC SIGNAL  
AND INTERSECTION WIDENING PROJECT #73354  
AGREEMENT # AGMT 07-1404**

**THIS CANCELLATION ADDENDUM** is to the Construction Responsibility and Reimbursement Agreement between the County of El Dorado and the El Dorado Irrigation District for the Durock Road and Business Drive Traffic Signal and Intersection Widening Project #73354, Agreement # AGMT 07-1404 (hereinafter referred to as "Agreement") made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and the El Dorado Irrigation District, a special district created pursuant to State law, whose principal place of business is 2890 Mosquito Road, Placerville, California, 95667(hereinafter referred to as "EID");

**RECITALS**

**WHEREAS**, EID and County previously agreed to incorporate the upgrade and replacement of sewer main located in ground along Durock Road, inside of County Project # 73354 limits, into the scope of the County's Project pursuant to the Agreement, incorporated herein and made by reference a part hereof;

**WHEREAS**, County experienced delays in advertising the Project and at the same time EID is prepared to contract for other work on this sewer main into which this subject work could be incorporated. As a consequence, the parties have agreed to proceed separately with their respective projects;

**WHEREAS**, the parties therefore desire to cancel the Agreement and all obligations pursuant thereto in their entirety;

**NOW, THEREFORE**, County and EID mutually agree as follows:

Agreement #07-1404 is hereby cancelled and is of no force and effect.
