



RESOLUTION NO. 247-2018

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

SOUTH TAHOE REFUSE CO., INC. SCHEDULE OF RATES FRANCHISE AREAS A and B

WHEREAS, a public hearing was held on December 11, 2018, for the purpose of adjusting solid waste collection rates for the South Tahoe Refuse Co., Inc. (South Tahoe Refuse) Franchise Areas A and B; and

WHEREAS, County Ordinance section 8.42.150 provides that the Board of Supervisors shall set the rates to be charged by a franchisee at such times as the Board of Supervisors deems appropriate; and

WHEREAS, pursuant to County Ordinance section 8.42.170 and Government Code section 66016, the franchisee has provided written notice to each ratepayer of the proposed adjustment in a form approved by the County of the time, date, and place of public hearing to set rates and the notice was provided at least ten but no more than sixty days before the public hearing; and

WHEREAS, pursuant to County Ordinance section 8.42.170 and Government Code section 66016, notice of the time, date, place, and purpose of the public hearing has been published in a newspaper of general circulation printed and published in the County, once each week, for two consecutive weeks prior to such hearing; and

WHEREAS, Resolution 227-2014, approved on December 2, 2014, by the Board of Supervisors, authorized the consolidation of the American River Disposal Franchise Agreement into the South Tahoe Refuse Franchise Agreement and authorized the Chair to sign the First Amendment to the South Tahoe Refuse Franchise Agreement consolidating American River Disposal into the South Tahoe Refuse Agreement; and

WHEREAS, Resolution 228-2014 and Resolution 209-2014, approved on December 2, 2014, by the Board of Supervisors, authorized a rate increase of 4% for American River Disposal, now referred to as Area B of the South Tahoe Refuse Franchise Agreement, and a 2.66% increase for South Tahoe Refuse, now referred to as Area A, respectively, to be effective January 1, 2015; and

WHEREAS, upon execution of the First Amendment to the South Tahoe Refuse Franchise Agreement, the Board of Supervisors authorized a series of two (2) additional 4% increases for Area B to become effective on January 1, 2016, Resolution 209-2015, approved on December 15, 2015, by the Board of Supervisors, and on January 1, 2017, Resolution 203-2016, approved on December 13, 2016, by the Board of Supervisors, after which, the Area B rate adjustments shall be governed by the South Tahoe Refuse Solid Waste Rate Setting Policies and Procedures Manual; and

WHEREAS, Resolution 204-2016, approved on December 13, 2016 by the Board of Supervisors, authorized a rate increase of 1.62% for Area A to be effective January 1, 2017; and

WHEREAS, Resolution 190-2017, approved on December 12, 2017, by the Board of Supervisors authorized a 9.34% increase for Franchise Areas A and B, with 6.26% of the increase to become effective on January 1, 2018, and the remaining 3.08% of the increase to become effective on January 1, 2019, in addition to any Board approved interim year rate adjustment; and

WHEREAS, the South Tahoe Refuse Franchise Areas A and B solid waste collection rates shall have a 3.11% increase effective January 1, 2019, for a total rate increase of 6.19%.

NOW, THEREFORE, be it resolved that effective January 1, 2019, the following rates are adjusted upward by 6.19% for the collection of solid waste within the South Tahoe Refuse Franchise Areas A and B:
