All cost including, CAO, Law Enforcement, and the 80%-90% of activity mandated by Gen. Law.

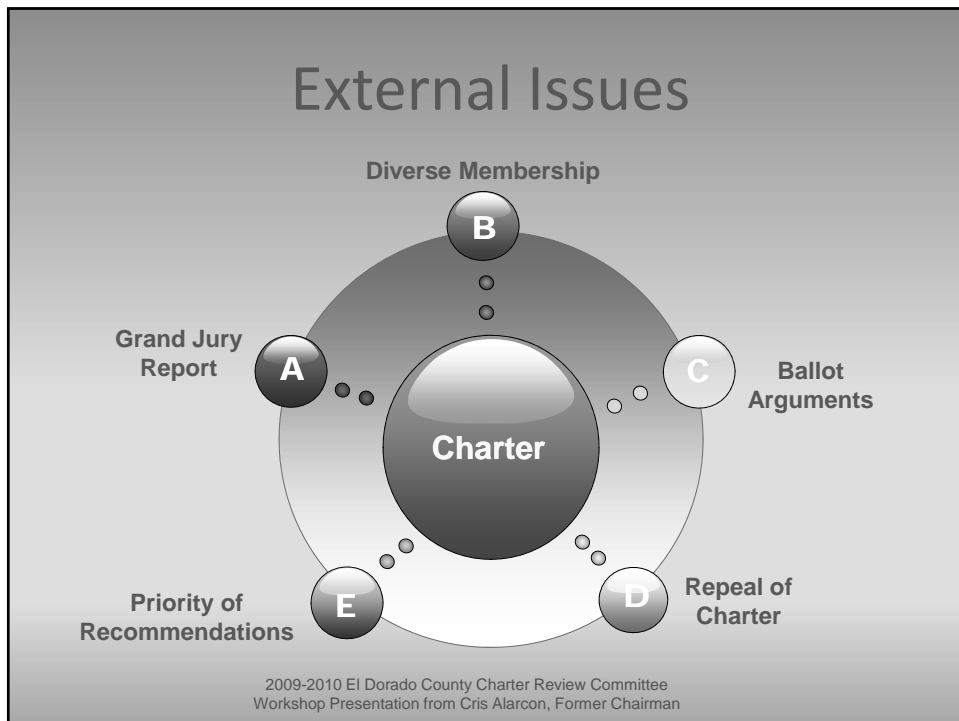
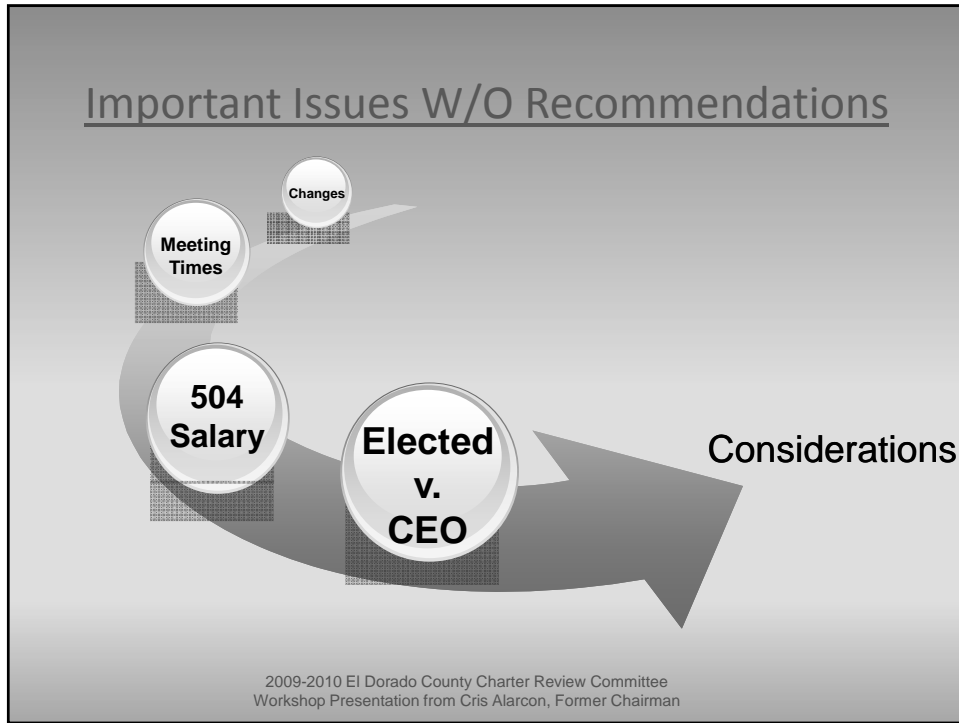
\$1,000,000+
