FOURTH AMENDMENT TO AGREEMENT FOR SERVICES #7125

THIS FOURTH AMENDMENT to that Agreement for Services #7125 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and LEHR Upfitters Opc LLC doing business as Lehr a limited liability company duly qualified to conduct business in the State of California, whose principal place of business is 631 N Market Street, Suite N, Sacramento, California 95834, and successor in interest to Stommel, Inc. (hereinafter referred to as "Contractor");

R E C I T A L S

WHEREAS, Stommel, Inc. was engaged by County to provide law enforcement vehicle tear down and build up services for its Sheriff's Office; pursuant to Agreement for Services #7125, dated January 24, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, LEHR Upfitters Opc, LLC purchased the stock of Stommel, Inc., the legal entity that served as the Contractor under the original Agreement;

WHEREAS, the parties desire to amend the Agreement to reflect the Contractor's change in the legal entity from Stommel, Inc. dba Lehr Auto Electric to LEHR Upfitters Opc, LLC dba Lehr, as well as the County's approval of such change under Article XII of the Agreement;

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of January 27, 2026 to September 30, 2026, amending **ARTICLE II, Term**;

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-to-exceed compensation amount of the Agreement to \$2,000,000.00, amending **ARTICLE III, Compensation for Services**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Contractor mutually agree to amend the terms of the Agreement in this Fourth Amendment to Agreement on the following terms and conditions:

- I. Company Name Change:** The name "Stommel, Inc. dba Lehr Auto Electric" wherever it appears in the Agreement #7125, dated January 24, 2023, and in all subsequent amendments thereto, shall be replaced with "LEHR Upfitters Opc, LLC dba Lehr". All references in the Agreement and subsequent amendments to "Stommel, Inc. dba Lehr Auto Electric" shall be deemed to refer to LEHR Upfitters Opc, LLC dba Lehr, and LEHR Upfitters Opc, LLC dba Lehr expressly assumes all obligations of Stommel, Inc. under the Agreement and its subsequent

amendments. County hereby approves the assignment of the Agreement and its subsequent amendments to LEHR Upfitters OpcO, LLC pursuant to Article XIII of the Agreement.

II. **ARTICLE II, Term**, of the Agreement is amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective when fully executed by the parties hereto and shall expire on September 30, 2026.

III. The fourth paragraph of **ARTICLE III, Compensation for Services**, of the Agreement is amended in its entirety to read as follows:

ARTICLE III

Compensation for Services: The total amount of this Agreement, as amended, shall not exceed \$2,000,000.00 inclusive of all costs and expenses.

Except as herein amended, all other parts and sections of Agreement for Services #7125 shall remain unchanged and in full force and effect.


