



## RESOLUTION NO. **055-2017**

### OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

**WHEREAS**, County Ordinance Code section 5.04.050 defines “carnival” as including the operation of any two or more of the following devices within five hundred feet (500’) of each other: merry-go-round, Ferris wheel, and carnival-type ride, shooting gallery or pony ride; and

**WHEREAS**, the operation of a carnival requires that the operator obtain a business license pursuant to County Ordinance Code section 5.12.050; and

**WHEREAS**, County Ordinance Code section 5.12.050 requires that prior to issuance of the business license, the operator obtain a resolution of the Board of Supervisors declaring that the public health, safety and welfare will not be endangered by the business at the location specified in the business license application, and the operation of the business will not violate any zoning or health laws or regulations; and

**WHEREAS**, prior to the adoption of any such resolution, the Board of Supervisors must hold a public hearing, notice of the time, place and purpose of which has been published in a newspaper of general circulation in the County at least ten (10) days before the hearing whereas such notice has been properly published; and

**WHEREAS**, on February 9th 2017 Butler Amusements Inc., submitted a business license application, including all necessary inspections and staff signatures and paid all necessary fees for the operation of a carnival within the unincorporated area of the County of El Dorado from April 6, 2017 through April 9, 2017; and

**WHEREAS**, the carnival will operate in Town Center East, a subject of Planned Development 94-04, which provides for a variety of special events to occur and has a traffic plan for such special events.

**NOW, THEREFORE, BE IT RESOLVED** by the Board of Supervisors that the Board finds the applicant meets the requirements for the issuance of a business license for the operation of the carnival; that the operation of the business will not endanger the public health, safety and welfare and that the operation of the business will not violate any zoning or health laws or regulations.

**BE IT FURTHER RESOLVED** that the Board of Supervisors hereby adopts this resolution authorizing the tax collector to accept and approve the application for a business license submitted by Butler Amusements, Inc. for the operation of a carnival in Town Center East from April 6, 2017 to April 9, 2017.
