

AGREEMENT FOR SERVICES 653-PHD0707
AMENDMENT II

This Amendment II to that Agreement for Services 653-PHD0707, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and California Shock/Trauma Air Rescue, d.b.a., CALSTAR, a nonprofit regional air ambulance service, duly qualified to conduct business in the State of California, whose principal place of business is 4933 Bailey Loop, McClellan, CA 95652, (hereinafter referred to as "CALSTAR") and whose Agent for Service of Process is Lynn D. Malmstrom, 4933 Bailey Loop, McClellan, CA, 95692;

RECITALS

WHEREAS, CALSTAR has been designated, approved and authorized by County to provide emergency air ambulance dispatch services, in accordance with Agreement for Services 653-PHD0707, dated October 30, 2007 and Amendment I dated July 27, 2010, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of the original Agreement, thereby amending **Article IV - Authorization Term**; and to update contact information, thereby amending **Article IX - Notice to Parties**;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #653-PHD0707 shall be amended a Second time as follows:

1) **ARTICLE IV** shall be amended in its entirety to read as follows:

ARTICLE IV

Authorization Term: This Agreement shall become effective when fully executed by both parties hereto and shall expire on August 31, 2010. This Agreement may be extended for one additional thirty (30) month period if mutually agreed by both parties hereto.

The parties hereto agree to extend the term of this Agreement through February 28, 2013 unless earlier terminated pursuant to the provisions under Article XIX herein.

2) **ARTICLE IX** shall be amended in its entirety to read as follows:

ARTICLE IX
