The County of El Dorado Planning Commission will hold a public hearing in the Planning Commission Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on October 23, 2025, at 8:30 a.m., to consider the following: PLANNED DEVELOPMENT PERMIT PD21-0002/Latrobe Commercial Condominiums submitted by Karina Guerrieri for a gated commercial development consisting of microflex office space, and includes associated improvements for parking, lighting, and landscaping. Following are the specific requests for this permit: a) Four (4) buildings totaling 76,243 square feet of office and warehouse space on approximately five (5) acres; and b) Exception from the Community Design Guidelines and Standards, Landscaping and Irrigation Standards for the interior parking The property, identified by Assessor's Parcel Numbers 117-088-022 and 117-088-023, consisting of 11.84 acres, is located on the east side of Robert J. Mathews Parkway, adjacent to the west side of Latrobe Road. approximately 400 feet northwest from the intersection of Latrobe Road and Investment Boulevard, in the El Dorado Hills Business Park, within the El Dorado Hills Community Region, in the El Dorado Hills area, Supervisorial District 2.
