### FOURTH AMENDMENT TO AGREEMENT FOR SERVICES #4404

**THIS FOURTH AMENDMENT** to that Agreement for Services #4404 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter "Participating Agency" or "County"), and Hunt & Sons, LLC., a limited liability company formed in Delaware duly qualified to conduct business in the State of California, whose principal place of business is 65 Enterprise Suite 425, Aliso Viejo, California 92656, and whose mailing address is 2331 Citywest Boulevard, Houston, Texas 77042 (hereinafter referred to as "Contractor");

### RECITALS

**WHEREAS**, County, as a Participating Agency, utilized the Sacramento Area Council of Governments ("SACOG") Agreement #1920029 to enter into an agreement with Contractor;

**WHEREAS**, Contractor has been engaged by County to provide cardlock fueling services pursuant to Agreement for Services #4404, dated January 14, 2020, First Amendment to Agreement #4404, dated September 13, 2022, Second Amendment to Agreement #4404, dated January 13, 2023, and Third Amendment to Agreement #4404, dated August 28, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

**WHEREAS**, the parties hereto desire to amend the Agreement to extend the expiration date of September 1, 2024, for an additional ninety (90) days, amending **ARTICLE 5, Other Special Terms and Conditions**;

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Fourth Amendment to Agreement on the following terms and conditions:

II. **ARTICLE 5, Other Special Terms and Conditions**, of the Agreement is amended in its entirety to read as follows:

The term of this Agreement shall become effective upon final execution by both parties hereto and shall cover the period of January 24, 2020 through November 30, 2024, as amended.

Except as herein amended, all other parts and sections of Agreement for Services #4404 shall remain unchanged and in full force and effect.
