**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**Resolution for Road Closure for the 2011  
“Apple Hill Harvest Run” Event**

**WHEREAS**, The Camino School Parents’ Club and the Apple Hill Growers’ Association (sponsors) desire to hold the 32<sup>nd</sup> Annual “Apple Hill Harvest Run” Event on Sunday, November 6, 2011; and

**WHEREAS**, said sponsors have applied for a Road Closure Permit pursuant to Vehicle Code 21102(e), Ordinance Code §12.37.010 et seq., and County Resolution 110-79 in order to promote the “Apple Hill Harvest Run” Event on Sunday, November 6, 2011; and

**NOW THEREFORE BE IT RESOLVED** that a full road closure be in effect for Larsen Drive between North Canyon Road and Cable Road; Larson Drive between North Canyon Road and Carson Road; and one-lane closures be in effect for Barkley Road (eastbound) between Larsen Drive and Carson Road; Cable Road (northbound) between Larsen Drive and Carson Road; D Street (northbound) between Carson Road and 2<sup>nd</sup> Street; 2<sup>nd</sup> Street (eastbound) between D Street and Larsen Drive; Carson Road (westbound) between Larsen Drive and North Canyon Road; North Canyon Road (eastbound) between Carson Road and Larsen Drive on Sunday, November 6, 2011, between 7:00 a.m. and 11:15 a.m., subject to conditions set forth in Resolution No. 110-79 dated May 1, 1979, and subject to conditions set forth in the “Application for Road Closure” submitted for this event.

This Resolution and the Application with conditions shall together constitute the Road Closure Permit.
