AMENDMENT I

THIS AMENDMENT I to that Agreement made and entered into on December 29, 2005 by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County") and Tahoe Youth & Family Services, a California Nonprofit Public Benefit Corporation qualified as a tax exempt organization under Section 501(c)(3) of the Internal Revenue Code of 1986, whose principal place of business is 1021 Fremont Avenue, South Lake Tahoe, CA 96150 (hereinafter referred to as "Contractor");

WITNESSETH

WHEREAS, Contractor is currently under agreement with County to provide counseling and support services for high risk youth enrolled in the Comprehensive Drug Court Implementation (CDCI) Grant Drug Court Program; and

WHEREAS, County has need to reappropriate program funding and said reappropriation is allowed under the current agreement; and

WHEREAS, County and Contractor mutually agree to decrease funding to Contractor;

NOW, THEREFORE, County and Contractor mutually agree to replace **Article III, Compensation for Services**, in its entirety with the following:

ARTICLE III

Compensation for Services:

- A. Payment for drug treatment/ancillary services for the term of the contract shall not exceed \$6,800.00. The term of the grant award spans multiple County fiscal years. Therefore, Contractor payments for drug treatment and ancillary services are subject to certain time restrictions, in addition to the maximum allowable amounts stated above. The applicable time restrictions are shown on the following table:

- B. County shall reimburse Contractor within forty-five (45) days of receipt of original invoices that are submitted to the Public Health Department Fiscal and Administrative Services Division on the County approved invoice form, are complete and accurate, and include all County required back-up forms, reports, or other documentation.
