Re: Notice of Withdrawal Request and Withdrawal from the California Regional Mental Health System Coalition, a Joint Powers Authority (hereinafter the “Coalition JPA”) Notice of Termination of Memorandum of Understanding Between the California Regional Mental Health System Coalition and the County of El Dorado

Members and Formers Members of the Coalition JPA:

Article VI, Parties, Section 1.2<sup>1</sup>, Withdrawal, subsection (a) Conditions, provides that any Member desiring to withdraw from the Coalition may do so if the following condition is met: (i) The request to withdraw is submitted to all the remaining Members on or before April 1<sup>st</sup> of the then current Fiscal Year. The requested withdrawal will be effective at the end of that Fiscal Year.

Please take notice that in accordance with Article VI, Section 1.2(a), entitled Withdrawal (a) Conditions, the County of El Dorado (“El Dorado”) hereby gives notice to all members of the Coalition JPA, both remaining and prior, of El Dorado’s withdrawal request from the Coalition JPA. In accordance with that Section, El Dorado’s withdrawal is automatically effective at the end of this fiscal year, close of business June 30, 2012 without any further action or notice.

Please take further notice that Section, and Section 6.2 of the Memorandum of Understanding between the California Regional Mental Health System Coalition and the County of El Dorado, executed by El Dorado on September 27, 2005 (“MOU”), the MOU will terminate by its terms on June 30, 2012 in accordance with the effective date of El Dorado’s withdrawal from the Coalition JPA.
