## OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

### Resolution to Establish/Amend Speed Restrictions

**WHEREAS**, El Dorado County Ordinance Code Section 10.08.020 authorizes the Board of Supervisors to establish speed restrictions: and

**WHEREAS**, on September 2, 2009, the West Slope Traffic Advisory Committee recommended amending the speed restrictions;

**BE IT FURTHER RESOLVED** that Resolution No. 247-81, which establishes speed restrictions pursuant to Section 10.08.020 of the El Dorado County Ordinance Code, is amended as follows:

#### **DELETE:**

~~“(y) Missouri Flat Road (No. 9) forty five (45) miles per hour from a point 300 feet south of Forni Road (No. 312) to a point 300 feet north of El Dorado Road (No. 8).”~~

~~“(y) Missouri Flat Road (No. 9) forty (40) miles per hour from a point three hundred feet (300’) south of Forni Road (No. 312) to a point 300 feet north of El Dorado Road (No. 8).”~~

~~“(al) Pleasant Valley Road (No. 77) twenty five (25) miles per hour from State Route 49 in El Dorado westerly to a point 0.14 mile west of State Route 49.~~

~~“(aj) Pleasant Valley Road (No. 77) forty (40) miles per hour from Mother Lode Drive (No. 240) to a point 1.14 mile east thereof.”~~

#### **ADD:**

“(fw) Missouri Flat Road (No. 9) forty-five (45) miles per hour from a point three hundred feet (300’) north of El Dorado Road (No. 8) to State Route 49.”

“(fx) Pleasant Valley Road (No. 77) forty five (45) miles per hour from Mother Lode Drive (No. 240) to a point 690 feet west of El Dorado Road (No. 8).”

“(fy) Pleasant Valley Road (No. 77) thirty five (35) miles per hour from a point 690 feet west of El Dorado Road (No. 8) to a point 1,155 feet east of El Dorado Road (No. 8).”

“(fz) Pleasant Valley Road (No. 77) twenty five (25) miles per hour from a point 1,155 feet east of El Dorado Road (No. 8) to the intersection of State Route 49.”
