

MEMORANDUM OF UNDERSTANDING #8320
AMENDMENT I

This First Amendment to that Memorandum of Understanding (MOU) #8320, is made and entered into by and between the County of El Dorado Health and Human Services Agency (hereinafter referred to as "HHSA"), and the County of El Dorado Probation Department (hereinafter referred to as "Grantee");

RECITALS

WHEREAS, County of El Dorado Probation Department ("Grantee") was referenced as "Subrecipient" in the fully executed MOU #8320, dated May 21, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "MOU"), in which this First Amendment to that MOU will revise that reference to instead refer to County of El Dorado Probation Department as "Grantee;"

WHEREAS, Grantee has been engaged by HHSA to provide Opioid Remediation Activities in El Dorado County, pursuant to the MOU;

WHEREAS, the parties hereto desire to amend the MOU to increase the not-to-exceed compensation amount of the MOU by \$193,000.48 amending **ARTICLE I, Use of Funds and Payment**;

WHEREAS, the parties hereto desire to amend the MOU to extend the expiration date of June 30, 2025 for one (1) additional year, amending **ARTICLE II, Term**;

WHEREAS, the parties hereto desire to amend the MOU to update language, amending **ARTICLE V, Notice to Parties**, and **ARTICLE XVIII, Administrator**;

WHEREAS, unless otherwise specified herein, the following terms and conditions shall be effective upon final execution by both parties hereto of this First Amendment to that MOU #8320;

NOW THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, HHSA and Grantee mutually agree to amend the terms of the MOU in this First Amendment to MOU #8320 on the following terms and conditions:

- 1) All references to County of El Dorado Probation Department as "Subrecipient" throughout this MOU are hereby revised to refer to County of El Dorado Probation Department as "Grantee;"

- 2) **ARTICLE I, Use of Funds and Payment**, of the MOU is amended in its entirety to read as follows:

ARTICLE I

Use of Funds:

- A. Grantee shall perform activities as described in the submitted grant application as approved by the Opioid Remediation Panel as defined in Exhibit A, marked "Application," incorporated herein and made by reference a part hereof.
- B. All Grantee activities performed through this MOU must also adhere to the approved list of opioid remediation uses as listed in Exhibit B, marked "Funding Uses," incorporated herein and made by reference a part hereof, with the schedules included in Exhibit B as follows:
- Schedule A: Core Strategies
 - Schedule B: Approved Uses

Reporting Requirements:

Grantee shall submit activity and data reporting to EDCOSF@edcgov.us, Attn: OSF Quarterly Reporting, in accordance with Exhibit C, marked "Opioid Settlement Funds Grantee Reporting Requirements," incorporated herein and made by reference a part hereof.

Payment:

Grantee shall be subawarded Opioid Settlement Funds in the amount of \$386,000.96.

Within sixty (60) days of execution of this Agreement, County will advance Fiscal Year 2024-2025 funds to Grantee.

HHSA agrees to pay Grantee within forty-five (45) calendar days via journal entry for distribution of the Fiscal Year 2025-2026 Opioid Settlement Funds. Funds shall be used in accordance with the approved Grantee Application on file and in accordance with the approved list of Opioid Remediation Uses in Exhibit B.

Grantee shall revert any unspent funds that remain at the end of the term of this MOU back to the HHSA, for replenishment to County's Opioid Remediation Fund account via journal entry. Grantee will ensure that unspent funds are returned to HHSA within sixty (60) days of the end of the term of this MOU.

- A. Remittance shall be addressed as indicated in the table below or to such other location as HHSA or Grantee may direct per the Article titled "Notice to Parties."

Grantee shall keep and maintain all necessary records to properly and accurately reflect all costs claimed to have been incurred in order for HHSA to properly audit all expenditures. HHSA shall have access, at all reasonable times, to the records for the purpose of inspection, audit, and copying.

Funding shall not be used for political advocacy of any kind and shall not be used for individual person or business promotion or advertisement. Any person or business name mentioned in HHSA funded materials must be a sponsor or direct participant in the event of promotional effort. Any listing of service or product providers or co-sponsors must be inclusive. Any advertising space or time purchased by a person or business must be clearly and separately identified as paid advertising.

- 3) **ARTICLE II, Term**, of the MOU is amended in its entirety to read as follows:

ARTICLE II

Term: This MOU, as amended, shall become effective when fully executed by the parties hereto and shall expire on June 30, 2026.

- 4) **ARTICLE V, Notice to Parties**, of the MOU is amended in its entirety to read as follows:

ARTICLE V

Notice to Parties: All notices to be given by the parties hereto shall be in writing, with both the County Health and Human Services Agency and County Chief Administrative Office addressed in said correspondence and served by either United States Postal Service mail or electronic email. Notice by mail shall be served by depositing the notice in the United States Post Office, postage prepaid and return receipt requested, and deemed delivered and received five (5) calendar days after deposit. Notice by electronic email shall be served by transmitting the notice to all required email addresses and deemed delivered and received two (2) business days after service.


5) **ARTICLE XVIII, Administrator**, of the MOU is amended in its entirety to read as follows:

ARTICLE XVIII

Contract Administrator: The County Officer or employee with responsibility for administering this MOU is Salina Drennan, Alcohol and Drug Program Division Manager, Behavioral Health Division, Health and Human Services Agency (HHSA), or successor. In the instance where the named Contract Administrator no longer holds this title with County and a successor is pending, or HHSA has to temporarily delegate this authority, County Contract Administrator's Supervisor shall designate a representative to temporarily act as the primary Contract Administrator of this MOU and HHSA Administration shall provide the Grantee with the name, title and email for this designee via notification in accordance with the Article titled "Notice to Parties" herein.


Except as herein amended, all other parts and sections of that MOU #8320 shall remain unchanged and in full force and effect.
