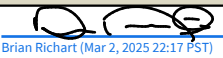

BUDGET TRANSFER JUSTIFICATION AND DESCRIPTION* (will be scanned into FENIX TCM)

On 11/21/24 the Community Corrections Partnership met and approved to increase revenue and expenditures for Probation and the Sheriff's Office for the following expenses.

Probation was approved for an additional \$70,000 in revenue and expenditures - \$20,000 for furniture to add office infrastructure for Sacramento County Office of Education (SCOE), El Dorado County Office of Education (EDCOE) and the Division of Adult Parole Operations at the Community Corrections Day Reporting Center, and \$50,000 to fund a pilot sex offender counseling program. Both of these items will be using Planning and Implementation funding.

Sheriff's Office was approved for an additional \$577,229 in revenue and expenditures - \$572,862 to cover additional inmate medical services through Wellpath for FY 24/25 and \$4,367 to cover El Dorado County's portion of a Transportation Application Development Fee. This will be using Planning and Implementation funding.
