**RESOLUTION OF VACATION  
Abandonment of Easement #2009-03  
Assessor's Parcel Number 117-100-30  
GHS Academy**

**WHEREAS**, the El Dorado County Board of Supervisors exercises the authority established by Section 8333 of the Streets and Highways Code, which authorizes the Board of Supervisors to summarily vacate public service easements by Resolution adopted in accordance with Section 8335 of the Streets and Highways code; and

**WHEREAS**, drainage and public utilities easements, as shown on Parcel Map 46-49, were dedicated to the County of El Dorado on February 28, 1997; and

**WHEREAS**, said offer for public utilities easements was accepted, but said offer for drainage easements was rejected on July 3, 1997, and said Parcel Map was recorded on July 9, 1997; and

**WHEREAS**, despite rejection, said offer for drainage easements is open in perpetuity and runs with the land; and

**WHEREAS**, on January 30, 2001, the County of El Dorado Board of Supervisors adopted Resolution of Vacation No. 024-2001, recorded as Official Record Document #2001-0005424, a copy attached hereto and made a part hereof, abandoning the public utilities easements; and

**WHEREAS**, due to a clerical error, said Resolution did not include the overlapping drainage easements; and

**WHEREAS**, the Department of Transportation has received a request from GHS Academy, present owners of Assessor's Parcel Number 117-100-30, to correct this error; and

**WHEREAS**, the Department of Transportation has determined that said easements herein described in Exhibit A and depicted in Exhibit B, and made a part hereof have not been used for the purposes for which they were dedicated preceding the proposed vacation, and has no objection.

**NOW, THEREFORE BE IT RESOLVED**, that from and after the date this Resolution is recorded, said offer for drainage easements described in Exhibit A and depicted in Exhibit B, is terminated and abandoned and no longer constitutes an offer for drainage easements. In addition, a Certificate of Correction is hereby authorized to be signed and may be recorded by the County Surveyor.
