AGREEMENT FOR SERVICES #653-PHD0707 AMENDMENT I

This Amendment I to that Agreement for Services #653-PHD0707, made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY") and California Shock/Trauma Air Rescue, d.b.a. CALSTAR; (hereinafter referred to as "CALSTAR");

RECITALS

WHEREAS, the Department of Public Health has been reorganized and is now known as the Public Health Division of the Health Services Department; and

WHEREAS, CALSTAR has been designated, approved and authorized by COUNTY to provide emergency air ambulance dispatch services, in accordance with Agreement for Services #653-PHD0707, dated October 30, 2007, incorporated herein and made by reference a part hereof; and

WHEREAS, the parties hereto have mutually agreed to extend the term of said Agreement in accordance with *Article IV - Authorization Term*, hereby amending Article IV; and

WHEREAS, the parties hereto have mutually agreed to modify the language under *Article IX – Notice to Parties*; and

WHEREAS, the parties hereto have mutually agrees to amend Article XIV - Administrator;

NOW THEREFORE, the parties do hereby agree that Agreement for Services #653-PHD0707 shall be amended a first time as follows:

- 1) All references in the original agreement to the "County Public Health Department" or "PHD" shall be deemed to refer to the Public Health Division of the Health Services Department.
- 2) Article IV provides that this Agreement may be extended for one additional two-year period; therefore Article IV shall be amended in its entirety to read:

ARTICLE IV

Authorization Term: This Agreement shall become effective when fully executed by both parties hereto and shall expire on August 31, 2010. This Agreement may be extended for one additional two-year period if mutually agreed by both parties hereto, in writing, not less than thirty (30) days prior to this Agreement's expiration.

The parties hereto agree to extend the term of this Agreement by one additional two-year period with an expiration date of August 31, 2012 unless earlier terminated pursuant to the provisions under Article XIX herein.

3) Article IX shall be amended in its entirety to read as follows:

ARTICLE IX

Notice to Parties: All notices to be given by the parties hereto shall be in writing and served by depositing same in the United States Post Office, postage prepaid, Certified, Return Receipt Requested.

Noticed to COUNTY shall be addressed as follows:

4) Article XIV shall be amended in its entirety to read as follows:

ARTICLE XIV

Administrator: The County officer or employee with responsibility for administering this Agreement is Richard Todd, Emergency Medical Services Agency Administrator, or successor.

Except as herein amended, all other parts and sections of that Agreement #653-PHD0707 shall remain unchanged and in full force and effect.
