

FISCAL COMMENTS:

In reviewing the data for 2012-2013, it was noted the number of participants between this year and the previous year decreased significantly, with an average of only 82% of the previous year's participants. As there was an increase in the Budgeted JJCPA funds for fiscal year 2012 - 2013 and a decrease in the population along with reduced length of time in program, the per-participant expenditures increased.

OUTCOME MEASURES COMMENTS:

The year to year goal for the Outcome Measures of the CART Program is a statistical result of "no change" from the previous year. When there is a statistically significant difference between the results from the previous year, the goal is "exceeded" or "not met" depending on whether it is an increase or decrease from the previous year. In reviewing the data for 2012-2013, a significant trend was noted; the number of participants between this year and the previous year has decreased significantly, with an average of only 82% of the previous year's participants in each category. Changes of note for the 2012-2013 CART Program are the addition of a school to the program, and, of the five (5) officers assigned to the CART Program, three (3) were new to the CART Program, with one officer being a new employee without previous probation officer experience. Additionally, the Supervisor for the CART Program was changed prior to the start of the year.

There are three (3) categories in the Outcome Measures for 2012-2013 that have a statistically significant change to deem the goal in those categories as "not met." They are; Rate of Completion of Community Service, Probation Violation Rate, and Education – Attendance – Other – Percent of Class Periods with Unexcused Absences.

Rate of Completion of Community Service: The goal of "no change" was not met. It should be noted that the previous year's data of 77.5% (2011-2012) appears to be a one year spike. This year's rate of 71.4% completion is significantly higher than the 62.7% from the year before last (2010-2011). What is encouraging in this category is the overall five (5) year trend appears to be the Rate of Completion of Community Service is increasing.

Probation Violation Rate: The goal of "no change" was not met. The number of participants in this category between this year and the previous year decreased significantly, having only 77% of the previous year's (2011-2012) participants. Further, it appears the data from the previous year (2011-2012) is a one year dip. The number of violations for this year (2012-2013) are actually fewer than the previous year (2011-2012), and when compared to the 22.9% rate from the year before last (2010-2011), this year's rate of 22.4% continues a three (3) year downward trend in the Probation Violation Rate.

Education – Attendance – Other – Percent of Class Periods with Unexcused Absences: This year, the CART minors have a substantially higher percent of unexcused absences with 11.9% vs. 5.9% for 2011-2012. This difference is statistically significant therefore the goal of "no change" is not met. However, the 2011-2012 data appears to be a one year dip. In comparison, the 2012-2013 rate is not significantly higher than the 2010-2011 (7.3% vs.11.9%). Additionally, the process that school staff submit attendance records to the CART officer changed at the beginning of the 2012-2013 year and information about attendance is not immediately available as it has been in previous years, thus delaying the CART officer's response to an absence.

Summary: When comparing the 2012-2013 outcomes to the updated 2011-2012 outcomes, the results are not as dramatic as last year's. In 2011-2012, several areas received decreases that were less than any prior program year. Results indicate that CART's goal of meeting or surpassing the outcomes of last year's very successful program was achieved when compared to the year before last (2010-2011). The goals of the other major Outcome Measures of the CART program, to raise academic attainment and reduce recidivism, were met. Further, there is one (1) category where the statistical change resulted in "exceeding" the previous year; Completion of Probation Rate.
