Subject: Relocation of Hangtown Haven to Perks Court

El Dorado County, Board of Supervisors,

I am Jillian Ryan, a full time student at California State University of Sacramento and a mother of two. My sons Evan, 4 years old, Vaughn, 8 months old, their father and myself live on Bestafa Court in Placerville. Having been raised here in Placerville we want nothing more than to raise our boys here. We love this town and feel we contribute to the community as homeowners and taxpayers. We purchased our home in January 2012 with hopes of residing here permanently.

Bestafa Court is a secret gem to Placerville; it is a great location with beautiful homes and remarkable neighbors, whom we have developed warm and respectful relations with. Our very private and quiet cul-de-sac allows us a sense of security; however, our backyard is adjacent to Perks Court; and I ask that you *vote No on the relocation of the Hangtown Haven to Perks Court*. As of now, our home is a safe and wonderful place for us to raise our children. We have an acre for the boys to play and we feel they are safe. The relocation of Hangtown Haven will have a detrimental impact on the quality of life for my family. I am a caring mother and a productive member of this community and pride myself on my home and our town.

The serious impact of the homeless population for El Dorado County is evident in the condition of Broadway in Placerville, and its increasing number of homeless inhabitants. It is apparent that a change is necessary for these individuals to continue to reside here by the disarray of the current state of Broadway, but Perks Court is not the answer. The revolving door of panhandlers, squatters, and the trash littered about have become the continuous appearance of Broadway and have deterred many businesses from thriving, housing relocation, and an increase in crime.

Hangtown Haven has become a safe zone for these individuals to become permanent occupants and the members are only increasing in numbers. Over the last year, the introductory period for the Hangtown Haven, it is clear to see that they are catering to a permanent population and have not assisted in the transition of these individuals back into a productive workforce. I ask that you please take time to consider the negative impact this relocation to Perks Court will have on my family and more importantly this wonderful community.

Within a two-mile radius of Perks court there a number of public schools – Indian Creek Elementary, Herbert Green Middle School, and in-home preschools and daycares, as well as churches, each housing our children on a daily basis and providing parents like myself a sense of security while we receive a higher education and work full-time jobs. Perks Court is not a location that is sufficient or acceptable for our county's homeless problem.

Perks Court is directly across the street from one of Placerville's nicest hotels, The Best Western. This encampment will be visible from the Hotel and will detour incoming patrons. Perks Court is visible from Highway 50 and on the corner of Missouri Flat, which is our beautiful Gateway to Placerville's largest and growing revenue district supporting both Placerville and El Dorado County. All

tourism for downtown Placerville, Apple Hill, our county's wineries, the river and all other attractions will be affected negatively by this relocation of Hangtown Haven.

Missouri Flat has most recently received a bike trail that is easily accessible and spans the great Placerville area. I enjoy walking with friends and family there now and see the relocation of Hangtown Haven being a burden to the trail and the safety of its users. It will give the homeless more opportunity to venture from their encampment and burden our town with their lack of productiveness. I will no longer feel safe on the trail with my sons knowing they are utilizing it readily and possible residing along it. The remodel of Missouri Flat has provided sidewalks and a newly remodeled overpass making it more accessible for the foot traffic for these homeless individuals on a daily basis once they are living on the corner.

There are many homes, businesses, shopping centers, restaurants, churches, and schools that will be subject to the affliction put on our community to carry these individuals. As a community it is our job to protect and serve our fellow neighbors those homeless and those not, but there is no perk for us as a community to move this establishment to Perks Court. Perks Court is a prime location for Placerville to have something remarkable to help flourish, not promote our county's problem with a safe haven for homeless individuals.

There is a place for this encampment; a place for these citizens to be safe from harm but it is not behind my home and not on the corner of the great town of Placerville.

When I was a child I lived at Perk's corner. My father ran the station there, People often dumped their unwanted pets at Perk's corner hoping someone else would take care of them. The city of Placerville is now doing the same thing, only they are attempting to dump the inhabitants of their homeless settlement. They claim the settlement is a total success, ground breaking even. If this is true, why are they so totally determined to not just relocate the settlement, but move it outside the city limits so they will have no further responsibility or liability for it. Clearly there is a hidden agenda here as people do not dump something that is an unqualified success. There is a lot of the truth that is not being told here.

They also claim that high volume traffic on Broadway is a danger. Have they seen the traffic on Missouri Flat Road? Dear El Dorado County Supervisor,

I understand that, after several postponements, you will be addressing the option of providing a facility for the homeless in El Dorado County on September 10. I have personally done some volunteer work with the Resource Center and Upper Room in Placerville and would appreciate the opportunity to enlighten you regarding this issue. I have visited the Hangtown Haven on Broadway twice and have found it to be clean and organized. What these folks have done there is built a community. One of the major problems of the homeless population is the protection of their belongings. It is impossible for them to get needed resources, look for a job, or go to places like the Upper Room, when they can't leave their belongings because of fear they'll be taken. The community they have built at Hangtown Haven provides much needed camaraderie and safety that being a member provides. Other issues are lack of bathroom facilities, clean running water, and a place for trash. Hangtown Haven provides for all of these. The success of the camp should be applauded and supported. I would like to see the current camp kept open for the citizens of Placerville and the new site option at Perk's Court for other area residents. Many volunteer hours have been clocked in an effort to provide for this segment of our population and are a testament to its success. As county representatives, I hope to see you regard this issue with compassion and support for this vulnerable segment of our community.

I've included some information from the National Coalition for the Homeless . . .

- Rural homelessness is a silent epidemic afflicting thousands of individuals and families every year
- In addition to the causal factors of homelessness among all people who experience it, additional economic, social, and geographic factors unique to rural areas exacerbate homelessness among the residents of rural communities
- Rates of homelessness in many rural counties exceed that of urban and suburban counties.
- There is a dearth of homeless assistance services in rural areas
- Most individuals and families experiencing homelessness in rural areas either go without even basic needs or they migrate to small cities and urban centers for assistance. Such forced migration leads to child and family trauma and disconnection from workplaces, relatives, and peer and professional supports

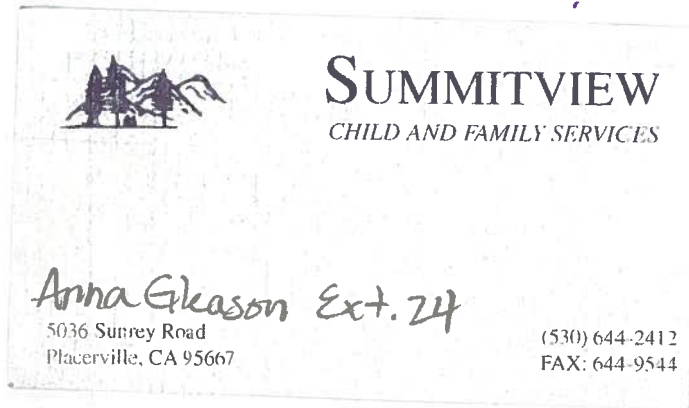
