CHIEF ADMINISTRATIVE OFFICE - ECONOMIC DEVELOPMENT UPDATE

Tiffany Schmid, Chief Administrative Office Principal Analyst, updated the Committee on the following items:

- 1) CEDAC's new Resolution was approved by the Board of Supervisors on December 5, 2017. Substantive changes include:
 - Increasing membership from 7 to 9 by removing the Alternate At-Large Member and adding two additional At-Large Members;
 - Increasing the term limit from two years to four years; and,
 - Adding the word 'community' throughout the resolution to emphasize CEDAC's focus on community and economic development.
- 2) The County is working with Sac Metro to publish a profile page in 'California's Capital Region - The Sacramento Valley' coffee table book.
- 3) The County received Greater Sacramento Economic Council's 'Paving the Way' award for our economic development efforts.
- 4) We are looking forward to a productive year with CEDAC's expanded membership.
