I am emailing per instructions in a letter I received from the County of El Dorado Planning Services about the Special Use Permit **S14-0009/Cell Tower Skyline Drive**. I want to go on record as a resident of this area who protests the proposed structure of a wireless 113-foot structure with accompanying antennas, equipment shelter, related ground equipment, HCAV unites, sound barrier walls and wood fence on the property identified by Assessor's Parcel Number 081-102-01.

There is ongoing research about the threat to human safety and health from such structures. Since arguments pro and con are abundant, I cannot understand why our residential neighborhood should allow such a risk to be present where we are living. I also am concerned that these structures are known to lower property values. Living in the mountainous area as we do, I trust there are other less-populated sites that can be used by New Cingular Wireless.

Thank for the opportunity to protest this event. I also plan to attend the public hearing on December 11, 2014 and appreciate the opportunity to protest in person.

To whom it may concern:

We are writing in response to the proposed Special Use Permit S14-0009/AT&T Cell Tower Skyline Drive and the accompanying Negative Declaration.

As residents of the Skyline neighborhood, we are opposed to the construction of a cell phone tower as explained in the Notice of Public Hearing and Negative Declaration.

Our concerns are the following:

- Threats to public safety and electrical utilities.
- Known and unknown health hazards to residents in the area.
- Increased noise levels from HVAC units, construction and maintenance of proposed facilities.
- Aesthetic degradation of the surrounding neighborhood.
- Increased traffic due to construction and maintenance of facilities
- Negative visual impacts of the 113 foot monopine tower, tower light at the top three feet, equipment shelter, sound barrier walls, and solid wood fence.
- Reduction of property values due to a commercial business development in an area zoned single family residential.

We are requesting the proposed Negative Declaration not be adopted and the Special Use Permit not be approved based on the information above.
