**Whereas**, Ponderosa High School and Pyro Spectaculars, Inc. desire to conduct a fireworks display at Ponderosa High School, 3661 Ponderosa Road, Shingle Springs on Friday, November 3, 2006, and,

**Whereas**, Section 8.08.050 of the County Ordinance Code restricts the use, possession, or discharge of fireworks to persons authorized by written order of the Board of Supervisors in full compliance with any conditions or restrictions contained in such order; and,

**Whereas**, the El Dorado County Fire Department, and/or the El Dorado County Sheriff's Department shall have the right to revoke the permission to hold the display at any time due to extreme fire or other specific danger, up to and including when the display is to begin; and,

**Whereas**, approval is contingent upon the obtainment of all permission, insurance and/or paid permits that may be needed from the County of El Dorado and/or other agencies;

**Now therefore be it resolved**, that the El Dorado County Board of Supervisors hereby grants Pyro Spectaculars, Inc. permission to conduct the requested display on Friday, November 3, 2006, only, and provided that they comply fully with the aforementioned and any other additional requirements deemed necessary by fire control authorities.
