**Title:** Authorization for the El Dorado County Department of Human Services to expend monies from the El Dorado County Children's Trust Fund, on behalf of the El Dorado County Child Abuse Prevention Council, for the purpose of sponsoring child abuse awareness, prevention and intervention events

**Recommendations:**

Human Services, Social Services Division, recommends that the Board adopt a resolution authorizing the El Dorado County Department of Human Services to expend monies from the El Dorado County Children's Trust Fund, #20-553-313, Index Code 7753313, on behalf of the El Dorado County Child Abuse Prevention Council, for the purpose of sponsoring child abuse awareness, prevention and intervention events conducted by other agencies, such as the 2007 El Dorado County's Kid's Expo (\$425) and future child abuse awareness, prevention and intervention conferences.

**Reasons for Recommendations:**

On April 9, 2002, the El Dorado County Board of Supervisors established a Child Abuse Prevention Council (CAPC) and designated that Council as the Children's Trust Fund Commission. According to the Welfare and Institutions Code, a CAPC's functions include, but are not limited to, the following:

- ◆ To provide a forum for interagency cooperation and coordination in the prevention, detection, treatment, and legal processing of child abuse cases.
- ◆ To promote public awareness of the abuse and neglect of children and the resources available for intervention and treatment.
- ◆ To encourage and facilitate training of professionals in the detection, treatment, and prevention of child abuse and neglect.
- ◆ To recommend improvements in services to families and victims.
- ◆ To encourage and facilitate community support for child abuse and neglect programs.

As Commission of the Children's Trust Fund (CTF), CAPC is authorized by the Welfare and Institutions Code, with Board of Supervisors' approval, to fund child abuse and neglect awareness, prevention and intervention activities with CTF monies. CAPC is requesting that the Board authorize the Department of Human Services to expend CTF monies from CTF #20-553-313, Index Code 7753313, on behalf of CAPC, in order to financially sponsor, with majority approval of the Council, child abuse and neglect awareness, prevention and intervention events conducted by other agencies, such as the annual El Dorado County's Kid's Expo and other child abuse awareness, prevention and intervention conferences.

**Fiscal Impact:**

None. The cost of sponsoring the 2007 El Dorado County Kid's Expo is \$425. Sponsorship of child abuse and neglect awareness, prevention and intervention events is included in CAPC's Board approved budget under Council Approved Programs and Child Abuse Prevention Month activities. A total of \$30,000 is budgeted for these activities during FY 2006/07. Costs specifically for sponsorship of FY 2006/07 events and conferences conducted by other agencies are not expected to exceed \$2,000. Approval of this resolution will also allow budgeting for and sponsoring of events and conferences conducted by other agencies in future fiscal years.


