

## RESOLUTION NO. 046-2010

## OF THE BOARD OF COMMISSIONERS OF THE EL DORADO COUNTY PUBLIC HOUSING AUTHORITY

A RESOLUTION ACKNOWLEDGING THE EL DORADO COUNTY PUBLIC HOUSING AUTHORITY AS A HIGH PERFORMING AGENCY, APPROVING SUBMITTAL TO THE DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) OF THE 2010-15 FIVE YEAR PLAN AND AMENDED ADMINISTRATIVE PLAN FOR THE SECTION 8 HOUSING CHOICE VOUCHER PROGRAM, APPROVING UPDATES TO THE FAMILY SELF-SUFFICIENCY PROGRAM ACTION PLAN, AUTHORIZING THE CHAIR'S SIGNATURE ON PHA CIVIL RIGHTS CERTIFICATION AND CERTIFICATIONS OF COMPLIANCE WITH THE PHA PLANS AND RELATED REGULATIONS, RECOGNIZING THE CONTRIBUTION OF THE PHA PARTICIPANT ADVISORY BOARD IN ASSISTING WITH CERTAIN ASPECTS OF THE AGENCY PLAN, AND APPROVING AMENDMENTS TO THE ADMINISTRATIVE PLAN TO COMPLY WITH HUD REGULATORY CHANGES.

WHEREAS, The El Dorado County Board of Supervisors, as the Board of Commissioners of the El Dorado County Public Housing Authority (EDCPHA), acknowledges that the EDCPHA is a high performing agency and is therefore subject to the United States Department of Housing and Urban Development (HUD) requirement to submit only Items 1.0 through 5.2 of the Five-Year Plan as determined under Title VII of the Housing and Economic Recovery Act of 2008 by the deadline of April 16, 2010, and

WHEREAS, Pursuant to changes in Section 8 Housing Choice Voucher Program regulations, the PHA Administrative Plan must be amended when changes are to be implemented, and

WHEREAS, the EDCPHA administers a Family Self-Sufficiency Program that requires periodic updates to the related Action Plan; and

WHEREAS, the PHA is required to sign the Civil Rights Certification and the PHA Certifications of Compliance with PHA Plans and Related Regulations, and

WHEREAS, Assistance of the PHA Participant Advisory Board with the amendment of the Administrative Plan is appreciated.

NOW, THEREFORE, BE IT RESOLVED by the Board of Commissioners of the El Dorado County Public Housing Authority as follows:

- 1. The El Dorado County Public Housing Authority (PHA) is authorized as required to submit Items 1.0 through 5.2 of the Five-Year Plan to the Department of Housing and Urban Development (HUD); and
- 2. The Board approves the updates to the Family Self-Sufficiency Program Action Plan; and
- 3. The Board hereby amends the PHA Administrative Plan as shown on the document titled "2010 Annual Administrative Plan Update - List of Revisions" for submittal to the Department of Housing and Urban Development for the Housing Choice Voucher Assistance Program; and
- 4. The Chair is authorized to sign the Civil Rights Certification and the PHA Certifications of Compliance with PHA Plans and Related Regulations; and
- 5. The PHA recognizes the contribution of the PHA Participant Advisory Board in assisting with the amendment of the Administrative Plan.
