

**County of El Dorado
Development Impact Mitigation Fee Report
Lake Valley Fire Protection District
FY 2013-14**

Pursuant to Section 66006 of the Government Code, the County is required to annually make available to the public specific information related to the prior year’s activity for development impact fees within 180 days after the last day of each fiscal year.

(A) A brief description of the type of fee in the account or fund.

Lake Valley Fire Protection District currently collects development impact fees based on continuing development within the District which places added responsibilities and costs upon the District.

(B) The amount of the fee.

Lake Valley Fire Protection District fees are as follows:

Residential Units	\$750.00 per Unit
Commercial, industrial and institutional – unsprinklered	\$0.32 per square foot
Office Buildings, industrial and institutional – sprinklered	\$0.18 per square foot
