

**ORDINANCE NO. 5018**  
**THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO DOES ORDAIN AS FOLLOWS:**  
**RELATED TO REZONING IN THE EL DORADO HILLS AREA, (El Dorado Springs 23):**

**Section 1.** The Official Zoning Map for the El Dorado Hills area is hereby amended to rezone the following described lands:  
**From:** Multi-Family Residential-Design  
**To:** One-Family Residential (R1) Control (RM-DC)

**El Dorado Hills Area:**  
**Assessor's Parcel No.** 117-010-05; being described as a portion of Section 15, T9N, R8E, M.D.M., consisting of 21.65 acres.

**Section 2.** This ordinance shall take effect and shall become effective thirty (30) days following the adoption hereof.
