County Air Pollution Control District Budgeting

Dictated by California Health and Safety Code – Sections 40130 & 40131

- Requires air districts to adopt their budgets in an open process, separate from other County budget processes, to ensure opportunity for the public to participate and comment on its budget prior to adoption.
- Requires that air district proposed budgets be made available to the public 30 days before the public hearing.
- Requires that air districts notify all current permit holders of the date/time/location of the public hearing and about the availability of the proposed budgets. Notifications were mailed to all EDC permittees.
- Requires that a public hearing is held at least 2 weeks before the hearing at which the air district budget is adopted.

Incentivizing Emission Reductions from Area and Mobile Sources

- Woodstove Replacement Incentives (Chimney Smoke RIP)
- EXPANDED Clean Lawn Equipment Incentive (CLIP)
- Electric / Plug-in Hybrid Vehicle Incentive (Drive Clean!)
- Residential Electric Vehicle Charger Incentive (CHARGE)
- Electric Vehicle Charging Infrastructure
- School Buses, Heavy Duty Trucks and Construction/Agricultural Equipment
- Motor Vehicle Emission Reduction Projects



FY2023-24 Grant & Incentive Accomplishments (thru May 28, 2024)

- Funded 7 agricultural tractor replacements and 1 school bus replacement with Carl Moyer grants.
- Used FARMER grants to fund replacement of 2 tractors and 1 ag UTV.
- Funded 1 school bus replacement with AB923 funds (1 of 11 awarded in FY2022-23).
- Awarded AB2766 grant to EDC Library for electric Bookmobile.
- Incentivized the replacement of 188 pieces of gas lawn equipment with cordless electric lawn equipment.
- Incentivized the replacement of 76 non-EPA certified woodstoves in El Dorado County, 1 in Placer County, and 2 in Amador County.
- Incentivized the purchase of 91 electric or plug-in-hybrid vehicles.

EXAMPLES - Carl Moyer Program Funded Agricultural Equipment & School Bus





Resulting in:

- 81% reduction in NOx
- 93% reduction in ROG
- 99% reduction in PM

EXAMPLES - Carl Moyer Program Funded Agricultural Equipment & School Bus



Black Oak Mine Union School District replaced 21 year-old diesel bus with electric bus

Resulting in:

- 100% reduction in NOx,
 ROG, and PM emissions (total approx. 2.8 tons/yr)
- Increased student safety (air quality, seatbelts, cameras, perimeter monitoring)

EXAMPLES - FARMER Program Funded Agricultural Equipment



Gold Hill Ranch – Replaced 47-year-old tractor

Resulting in:

- 82% reduction in NOx
- 94% reduction in ROG
- 99% reduction in PM

EXAMPLES - FARMER Program Funded Agricultural Equipment



Bluestone Meadow– Replaced 17-year-old gas powered UTV with electric

Resulting in:

 100% reduction in NOx, ROG, and PM emissions
