

El Dorado County Committee/Commission Overview 2025 Community Services Community Action Council (CAC)

PRESENTED TO THE BOARD OF SUPERVISORS ON NOVEMBER 18, 2025

## Purpose/Objective

- Community Action Agencies are mandated through the receipt of Community Service Block Grants (CSBG). In El Dorado County, the Health and Human Services Agency administers CSBG and facilitates Community Action Council meetings.
- ▶ The Community Action Council (CAC) seeks to involve the community, including elected public officials, private sector representatives, and especially low-income residents, in assessing local needs and addressing the causes and conditions of poverty.
- ▶ In order to reduce poverty in El Dorado County, the CAC focuses on available local, state, federal and private resources to assist low-income individuals and families to acquire useful skills and knowledge, to gain access to new opportunities, and to achieve economic self-sufficiency.

# History and Governing Documents

- ► Community Action Agencies are private or public nonprofit organizations that were created by the federal government in 1964 to combat poverty in geographically designated areas. Status as a Community Action Agency is the result of an explicit designation by local or state government.
- Community Services Block Grant Program (CSBG) regulations, Title 42 United States Code 9910(b) and CA Government Code Section 12751, require the Community Action Agency to maintain a tripartite board structure made up of elected public officials, private sector community agencies and lowincome representation by residents or organizations, to promote the participation of the community in the reduction of poverty.
- ► The council reviews the bylaws annually and is provided the option to make changes or edits to the bylaws at any time. The council recently drafted a Governance document that explains the roles of membership and the democratic selection process for new council members more in detail.

### Membership

- ► Membership is comprised of fifteen (15) with five (5) members in each of the three categories (3). (tripartite board)
  - Public Official Sector: Elected/Appointed members
  - 2. Low Income Sector: Individuals or an agency representatives of the low-income community
  - Community Sector: An agency or community group representing services to support the low-income community.
- The Officers of the Council are Chair and Vice Chair.
  - Officers are nominated and elected by a majority vote annually in May.
