I am returning the above-entitled contract for corrections to the information on page one of the original agreement. I recommend that references to the Inmate Welfare Fund Committee in the recitals be deleted since the County has no such committee. I have had an opportunity to talk with Captain Bob Altmeyer and Chief Probation Officer Joe Warchol and they agree that this information is inaccurate and should be changed. In addition, the appropriate party to this contract is the County of El Dorado and not the El Dorado County Sheriff's Office. Please revise the agreement and resubmit for our approval.
