

El Dorado County Behavioral Health Commission Purpose and Role

- The Behavioral Health Commission is established under **Welfare and Institutions Code** (WIC) 5604.
- ▶ WIC 5604.2 states the Commission's duties to "Review and evaluate the community's mental health needs, services, facilities, and special problems."
- ▶ The Commission serves in an advisory role to the Board of Supervisors.
- ▶ Behavioral Health Commission (BHC) Bylaws were updated and approved by the Board of Supervisors on February 11, 2025. (**Resolution 019-2025**.)
- **BHC Bylaws Article IV.** The Behavioral Health Commission shall "Review and evaluate behavioral health need, services, facilities and special problems in any facility within the county or jurisdiction where mental health or substance use disorder evaluations services are being provided.

El Dorado County Behavioral Health Commission Objectives

- Review and advise any county agreements entered into pursuant to California WIC
 Section 5650 (Performance Contract.)
- Advise the Board of Supervisors and the El Dorado County Behavioral Health Director as to any aspect of the local behavioral health program.
- ▶ Review and approve the procedures used to ensure citizen and professional involvement at all stages of the planning process as specified in California **WIC Section 5651**.
- Review each qualified applicant for the position of Behavioral Health Director, and make recommendations to the Board of Supervisors. The Commission shall be included in the selection process prior to the vote of the Board of Supervisors.
- Review and comment on the County's performance outcome data and communicate its findings to the California Mental Health Planning Council.

El Dorado County Behavioral Health Commission "Ad Hoc" Committees

An ad hoc committee is a temporary committee formed by a governing body to address a specific issue, task, or project that falls outside the responsibilities of existing standing committees. The term "ad hoc" comes from Latin, meaning "for this purpose."

- June: Ad hoc Committee to participate in Department of Health Care Services (DHCS) Behavioral Health Transformation (BHT) Proposition 1, Behavioral Health Services Act (BHSA) educational listening sessions.
- July: Ad hoc Committee to complete the 2024 Data Notebook.
- September: Ad hoc BHC Commission 2025 officers nominating committee.

 the need for lower client to clinician ratios.
- Impacts of Proposition 1, Behavioral Health Services Act (BHSA) on deliverable mental health and substance use disorder services.
- Need for transitional housing.

Review of Governing Documents

In November, the Behavioral Health Commission (BHC) reviewed and updated the Bylaws to meet new January 1, 2025 verbiage requirements for WIC 5604. The Commission forwarded the recommended revisions to the appropriate County agencies for approval and the revised BHC Bylaws were approved by the Board of Supervisors. February 11, 2025 (Resolution 019-2025.)



2025 Behavioral Health Commission Goals

- Hold monthly public Behavioral Health Commission meetings.
- Continue to review and evaluate mental health and substance abuse disorder services in El Dorado County.
- Hold educational presentations of behavioral health services provided to consumers by the Behavioral Health Division.
 - Hold informative Behavioral Health Services Act (BHSA) plan updates.
 - Work collaboratively on providing necessary deliverable services and programs to consumers of El Dorado County mental health and substance use disorder services.
