The County of El Dorado Planning Commission will hold a public hearing in the Building C Hearing Room, 2850 Fairlane Court, Placerville, CA 95667 on June 26, 2014, at 8:30 a.m., to consider Special Use Permit S13-0010/Salmon Falls Ranch Trail and Trailhead Facility submitted by AMERICAN RIVER CONSERVANCY to request a parking area, trailhead facility, and a trail system. The property, identified by Assessor's Parcel Numbers 104-060-48 and 104-060-07, consisting of 196.36 acres, is located on the east side of Salmon Falls Road, approximately one-fourth mile north of the Salmon Falls Bridge, in the Pilot Hill area, Supervisorial District 4. [Project Planner: Aaron Mount] (Negative Declaration prepared)*

*This is a notice of intent to adopt the negative declaration or mitigated negative declaration that has been prepared for this project and which may be reviewed and/or obtained in the County of El Dorado Planning Services, 2850 Fairlane Court, Placerville, CA 95667, during normal business hours or online at <http://edcapps.edcgov.us/Planning/ProjectInquiry.asp>. A negative declaration or mitigated negative declaration is a document filed to satisfy CEQA (California Environmental Quality Act).
