



RESOLUTION NO. 168-2012

OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

Resolution to Authorize the Interim Director of Transportation to Temporarily Close a Section of Bass Lake Road between City Lights Drive and Silver Dove Way for the Construction of the Bass Lake Road Full Improvements Phase 1A Project During the 2013 Construction Season

WHEREAS, the County plans to construct the **Bass Lake Road Full Improvements Phase 1A** for Capital Improvement Project No. 66109 during the 2013 construction season; and

WHEREAS, a new culvert will be constructed as part of the Project; and

WHEREAS, in order to construct the new culvert, Bass Lake Road between City Lights Drive and Silver Dove Way will need to be closed for a fifty-nine (59) hour period over a weekend from 6:00 p.m. on Friday to 5:00 a.m. on Monday; and

WHEREAS, an alternate access route/detour will be available during the temporary closure and traffic will be directed by signage to this route/detour; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e), the Board of Supervisors is authorized to temporarily close a portion of any street for the safety and protection of persons who are to use that portion of the street during the temporary closing; and

WHEREAS, pursuant to California Vehicle Code Section 21101 (e) and California Streets and Highways Code Section 942.6, the Board of Supervisors may designate the Director of Transportation to determine the exact dates and times for the closures;

NOW, THEREFORE, BE IT RESOLVED that the Interim Director of Transportation is authorized to order the temporary closure of Bass Lake Road between City Lights Drive and Silver Dove Way, for a fifty-nine (59) hour period over a weekend in order to trench across Bass Lake Road and set a new culvert and to establish an alternate access route/detour for traffic use during the time of temporary closure. The precise dates of the temporary road closure are to be determined by the Interim Director of Transportation, with notification of the pending temporary road closure and detour to be provided to the County Supervisor of District 1, business owners, residents, the general public, the El Dorado County Transit Authority and to safety and law enforcement agencies in the Project area, through direct communications, signage, or flyers.
