



## ORDINANCE NO. 5012

### THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO

#### DOES ORDAIN AS FOLLOWS:

Section 1, Chapter 3.29 of Title 3 of the El Dorado County Ordinance Code, sections 3.29.030 and 3.29.040, are hereby amended to add authority and establish new fees as follows:

### Chapter 3.29 Establishment of a Schedule of Fees for the Treasurer-Tax Collector's Office

#### 3.29.010 Title .

This chapter shall be known, and may be referred to, in all proceedings as the Schedule of Fees for the Treasurer-Tax Collector's Office. (Ord. 4651)

#### 3.29.020 Purpose .

The purpose of this ordinance is to establish a schedule of fees, authorized by law, in the amount reasonably necessary to recover the cost incurred by the County Treasurer- Tax Collector on behalf of the County in providing the products or services enumerated herein. (Ord. 4651)

#### 3.29.030 Authority .

The authority for the fees established herein is found in the California Government Code, sections 6157, 27013, 27361.3, 54985, 54986, 66018, and 66451.2, and the California Revenue and Taxation Code, sections 162, 2509.1, 2706, 2821, 2922, 3704.7, 3719, 4112, 4151, 4217, 4672, 4673, 4837.5, and 5832. #### 3.29.040 Fee Schedule .

The Treasurer-Tax Collector will hereafter collect the following fees for the services or product rendered:
