#### FIRST AMENDMENT TO AGREEMENT FOR SERVICES #7825

**THIS FIRST AMENDMENT** to that Agreement for Services #7825 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "COUNTY"), and Dewberry Engineers Inc., a New York corporation duly qualified to conduct business in the State of California, whose principal place of business is 8401 Arlington Boulevard, Suite 1, Fairfax, Virginia 22031, and whose local address is 11060 White Rock Road, Suite 200, Rancho Cordova, California 95670 (hereinafter referred to as "CONSULTANT").

## RECITALS

**WHEREAS**, CONSULTANT has been engaged by COUNTY to assist its Department of Transportation with as-needed construction support services for various COUNTY projects, pursuant to Agreement for Services #7825, dated September 26, 2023, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to increase the not-toexceed compensation amount of the Agreement by \$1,000,000, amending ARTICLE V, Allowable Costs and Payments;

WHEREAS, the parties hereto desire to add a new Article to include updated contract provisions, adding Exhibit F, "Iran Contracting Act Verification Form";

**NOW, THEREFORE**, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, COUNTY and CONSULTANT mutually agree to amend the terms of the Agreement in this First Amendment to Agreement for Services #7825 on the following terms and conditions:

- I. ARTICLE V, Allowable Costs and Payments, Section P, of the Agreement is amended in its entirety to read as follow:
  - P. The total amount payable by COUNTY for all Task Orders or Work Orders, including Task Order and Work Order amendments, and all costs, taxes, or expenses resulting from this Agreement shall not exceed \$1,475,000, as amended. It is understood and agreed that there is no guarantee, either expressed or implied that this dollar amount will be authorized under this Agreement through Task Orders or Work Orders.

#### II. The following Article of the Agreement is added to read as follows:

## ARTICLE LXV

**Iran Contracting Act Certification:** As required by Public Contract Code section 2204, for Agreements that are over \$1,000,000, CONSULTANT certifies its status regarding the Iran Contracting Act of 2010 and has duly executed Exhibit F, marked "Iran Contracting Act Verification Form," incorporated herein and made by reference a part hereof.

Except as herein amended, all other parts and sections of Agreement for Services #7825 shall remain unchanged and in full force and effect.

# IRAN CONTRACTING ACT VERIFICATION FORM
