**RESOLUTION MAKING A DETERMINATION OF PUBLIC BENEFIT AND APPROVING FINANCIAL SUPPORT FOR THE HOMELESSNESS THEORY OF CHANGE IN EL DORADO COUNTY**

**WHEREAS**, El Dorado County (“County”) recognizes that homelessness exists in the county; and

**WHEREAS**, the Board of Supervisors (“Board”) convened a Transitional Housing Task Force on September 10, 2013 to address homelessness in El Dorado County; and

**WHEREAS**, the Transitional Housing Task Force successfully completed Phase I of the Theory of Change process and presented an update on the effort to the Board on September 30, 2014; and

**WHEREAS**, the Board finds a benefit to the public is present and supports the Transitional Housing Task force and the Center for Violence-Free Relationship’s implementation of Phase II of the Theory of Change process, outlined in Exhibit A; and

**WHEREAS**, the funding provided herein supports the implementation of Phase II of the Theory of Change process and;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado authorizes the Auditor-Controller to disburse funding in the amount of \$13,000 to the Center For Violence-Free Relationships for the purpose of supporting implementation of Phase II of the Theory of Change process pertaining to homelessness in El Dorado County.
