THIRD AMENDMENT TO AGREEMENT FOR SERVICES #7389

THIS THIRD AMENDMENT to that Agreement for Services #7389 made and entered into by and between the County of El Dorado, a political subdivision of the State of California (hereinafter referred to as "County"), and Housing Group LLC, a limited liability corporation, doing business as HousingINC, duly qualified to conduct business in the State of California, whose principal place of business is 9240 Oak Leaf Way, Granite Bay, California 95746 (hereinafter referred to as "Consultant").

RECITALS

WHEREAS, Consultant has been engaged by County to provide a needs assessment and development of a preliminary scope and program administration services for its Planning and Building Department, Affordable Housing Unit, pursuant to Agreement for Services #7389, dated April 4, 2023, First Amendment to Agreement for Services #7389, dated April 2, 2024, and Second Amendment to Agreement for Services #7389, dated June 25, 2024, incorporated herein and made by reference a part hereof (hereinafter referred to as "Agreement");

WHEREAS, the parties hereto desire to amend the Agreement to extend the expiration date of July 8, 2026 for five (5) additional months, amending **ARTICLE II, Term**;

WHEREAS, the parties hereto desire to amend the Agreement to update the County's Contract Administrator, amending **ARTICLE XXIX, Contract Administrator**;

NOW, THEREFORE, in consideration of the foregoing and the mutual promises and covenants hereinafter contained, County and Consultant mutually agree to amend the terms of the Agreement in this Third Amendment to Agreement for Services #7389 on the following terms and conditions:

I. **ARTICLE II, Term**, of the Agreement is amended in its entirety to read as follows:

ARTICLE II

Term: This Agreement shall become effective when fully executed by the parties hereto and shall expire on December 31, 2026.

II. **ARTICLE XXIX, Contract Administrator**, of the Agreement is amended in its entirety to read as follows:

ARTICLE XXIX

Contract Administrator: The County Officer or employee with responsibility for administering this Agreement is Jennifer Morris, Sr. Administrative Analyst, Planning and Building Department, or successor.

Except as herein amended, all other parts and sections of Agreement for Services #7389 shall remain unchanged and in full force and effect.
