El Dorado County Roads - Background

Road Classification	West Slope	Tahoe	Total
Regional	345.8	24.5	370.3
Local **	569.8	134.5	704.3
Total	915.6	159.0	1074.6

**74.8 of local West Slope miles and 0.6 of local Tahoe miles are "unconstructed" or dirt roads.

Regional roads typically receive overlay surface treatment, while local roads typically receive chip seal surface treatment.

Total maintained miles = 1074.6

Less unpaved roads = -75.4

Constructed roads = 999.2

CORP Projects Include

- Prep work
 - Clear brush, trim trees, inspect & replace culverts
 - Remove pavement failures and repair asphalt

CORP Projects Include (cont.)

- Asphalt overlay
- Stripe and place pavement markers
- Install shoulder backing, clean ditches

DOT Airport Capital Improvement Program (ACIP) Annual Updating Process:

- November Annual meeting with FAA review Airport Layout Plan (ALP) and Draft ACIP for project screening
 - Review ALP for compliance with Aviation Design Standards. Propose revisions to ALP & ACIP. The Program Managers at FAA guide the Project Sponsor (County) in project ranking and fund eligibility
 - FAA circulates draft ACIP for funding potential to CTC, Federal and State aviation divisions
- January Update ACIP and submit to FAA
 - Based on FAA guidance for ranking and funding capabilities, create a project list for a five to seven year period and submit to FAA
- February thru June Submit project funding applications. County updates budget for next year ACIP potential projects
 - Based on Federal and State budget constraints
 - Project may request authorization for planning, design and construction work
 - Award engineering or construction contract and begin reimbursement process


