**OF THE BOARD OF SUPERVISORS OF THE COUNTY OF EL DORADO**

**RESOLUTION INCREASING THE ANNUAL BENEFIT ASSESSMENT FOR THE  
BARNETT BUSINESS PARK LIGHTING ZONE OF BENEFIT #98534  
WITHIN COUNTY SERVICE AREA #9**

**WHEREAS**, the Board of Supervisors of the County of El Dorado has formed County Service Area #9 pursuant to Title 3, Division 2, Part 2, Chapter 2.2 of the California Government Code and within that County Service Area (CSA) established zones of benefit; and

**WHEREAS**, street lighting service is an allowable extended county service pursuant to Government Code §25210.1; and

**WHEREAS**, the Board of Supervisors formed the Barnett Business Park Lighting Zone of Benefit on October 7, 1986 by Resolution 316-86 for the purpose of providing street lighting services; and

**WHEREAS**, the Board of Supervisors of the County acting as the governing Board of CSA #9 has caused to be prepared a written engineer's report determining the proportionate special benefit to each property to be assessed in relation to the entirety of the cost of the services, pursuant to the passage of Proposition 218, and the provisions of Article XIII D of the California Constitution, a copy of which engineer's report is on file at the Office of the Clerk of the Board of Supervisors at 330 Fair Lane, Placerville, California; and

**WHEREAS**, the Board of Supervisors of El Dorado County finds that a Benefit Assessment based upon the proportionate special benefit identified within the Barnett Business Park Lighting Zone of Benefit #98354 is the appropriate way to apportion the cost of providing street lighting services in accordance with the benefits to be conferred in said area; and

**WHEREAS**, all notices required by law have been duly given;

**WHEREAS**, the Board of Supervisors of El Dorado County held assessment ballot proceedings, including a duly noticed public hearing on July 29, 2008 at 10:00 a.m., in accordance with Article XIII D of the California Constitution; and

**WHEREAS**, on July 29, 2008, after public hearing, the Board determined that no majority protest was registered against increasing the

benefit assessment within the Barnett Business Park Lighting Zone of Benefit #98534;

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Supervisors of the County of El Dorado determines as follows:

1. That the following assessment be levied in each and every parcel identified in Exhibit A hereto and located within the boundaries of the Barnett Business Park Lighting Zone of Benefit #98534 within County Service Area #9 as based upon the Benefit Assessment formula attached hereto and incorporated as Exhibit B.
2. The benefit assessment as shown on Exhibit A is hereby adopted for the fiscal year 2008-09.
3. The benefit assessments shall be distributed in accordance with the final budget for the Barnett Business Park Zone of Benefit as approved by the Board of Supervisors during County budget hearings and amendments thereto.
4. The services to be provided are extended County Services as defined in County Service Area Law, Government Code §25210.1.

**BE IT FURTHER RESOLVED**, that the assessment as adopted and confirmed shall appear as a separate item on the tax bill for each parcel and shall be levied and collected in the same manner as County ad valorem taxes are collected, as more specifically set forth and authorized on subdivision (d) of §25210.77a of the Government Code.
